FIRE DEPARTMENT FIRST QUARTER REPORT 2006

**PURPOSE:** 

To provide Council with information relating to the Fire Department's activities

for the first quarter of 2006.

# **RECOMMENDATION:**

1. THAT this report be received for information purposes.

## **REPORT**

During the first quarter of 2006 this department responded to 3,199 incidents. This is down, slightly, from the first quarter of 2005.

### 1.0 FIRES

Ten fire investigations were completed during the first quarter with losses totaling an estimated \$273,000. They were due to the following act or omission:

1	Misuse of source of ignition	\$ 1,000
1	Misuse of material ignited	1,500
3	Mechanical/Electrical Failure/Malfunction	16,000
2	Human Failing	112,500
3	Undetermined	142,000

## 2.0 TRAINING DIVISION

Hazmat and Driver Training have reviewed and rewritten their training manuals, lesson plans, certification training needs and Operational Guidelines. Seminars were then held during the first quarter of 2006 using these new materials.

Our CPR recertification began in the first quarter and should be completed soon. All First Responder instructors attended a child birthing course. This component will be included as a module in the First Responder Level 3 course.

A Senior Officer Training course was held during this quarter, with members eligible for the Chiefs' positions in the Operations, Training and Fire Prevention Divisions.

Wildland firefighting training began in the first quarter and will continue into the second quarter bringing a new level of ability for our Department to fight these kinds of fires.

General training that took place during the first quarter included:

First Responder Course – 35 members completed the 4 week "on shift" course

First Responder Level 3-9 members completed the 1 week "off shift" course

Restricted Radio Operator Instructor – 8 members

Driver Training – 4 instructors completed course requirements

Driver Training – 6 new driver instructors

Driver Training – 2 members certified as assessment officers for Air Brake courses

Fit testing of self-contained breathing apparatus (SCBA) is almost complete. SCBA mask fitting ensures our members in, hazardous environments, do no inhale harmful gases. Yearly competency evaluations were also done for all members in SCBA confidence.

#### 3.0 FIRE PREVENTION DIVISION

During the first quarter of 2006 Fire Prevention staff attended various in-house and external training courses: Preliminary Plan procedures for Captains; Office Procedures; Senior Officers' Course and Fire Investigation.

The Division responded to requests for Fire Department participation in the community. Trucks were displayed and fire extinguisher demonstrations presented at a number of community events during the first quarter.

Division staff continued with its contribution to the city task force on problem premises, notably dealing with buildings open to intrusion.
