### MOVED BY COUNCILLOR CALENDINO: SECONDED BY COUNCILLOR BEGIN:

#### CARRIED UNANIMOUSLY

A) Ms. Elsie Dean, Burnaby Community Coalition, appeared before Council to discuss the affect privatization of public assets and the health care system will have on the quality of health care in Burnaby. Ms. Dean referred to health care systems in other countries, such as the United Kingdom and the United States, where overall financial costs are exorbitantly high and where insurance for individuals can be unaffordable or unattainable. The speaker identified various forms of privatization in BC, including contracting out of services and public private partnerships (P3s). The delegate noted the increase in assisted living facilities for seniors has not helped the shortage of long term care beds which is causing overcrowding in hospitals.

Ms. Valentina Maliarenko, spoke on the impact the changes to Provincial legislation, which now allows for the contracting out of health care services, has had on health care. The speaker noted changes at care facilities in Burnaby, including Willingdon Park Hospital and Dania Home, are not only affecting the medical and support staff but also the residents. Ms. Maliarenko suggested a two tier system will result in a number of issues such as a shortage of health care professionals in the public system and reduced quality of patient care.

Mr. Barry Morely spoke on behalf of business and noted that the current Canadian health care system offers a competitive advantage over business counterparts, particularly from the United States.

Mr. Shawn Hunsdale spoke on behalf of students expressing concerns with the affordability of health services. The speaker provided a number of solutions for public health care as recommended by Canadian Federation of Nurses' Unions.

In conclusion, Mr. Hunsdale noted that public health care is an important component of Canadian identity and that access to health care is a human right. The delegation presented a petition requesting the City of Burnaby, in partnership with informed local public health care groups, undertake a process of ascertaining and bringing to public attention the present and possible future impact of privatization of healthcare on this municipality.

B) Marion Hartley, President, Burnaby Teachers' Association, appeared before Council regarding two issues: the ongoing under-funding of education and the implications of the proposed "repurposing" of school boards.

Ms. Hartley referred to the Provincial budget announcement in February and their concerns with the Education Minister's promise for a 10% increase to private school funding, in comparison to the 2.3% increase for funding the public education system. The speaker noted this increase does not keep up with the rate of inflation and that it is currently unknown whether changes, as a result of the teachers' job action last fall, are to be covered under this amount. Ms. Hartley advised funding allocated to school boards to reduce class size and composition has been reduced and is no longer provided specifically for these purposes. The speaker noted Bill 33, introduced two weeks ago, does contain limits for class size and composition. The teachers are very pleased with the recognition of these issues, however, they have serious concerns regarding the lack of funding.

The second issue raised by the delegation is the proposed "repurposing" of school boards. Ms. Hartley noted this has also been called "subsidiarity" and "student centred leadership". The speaker advised there are currently two school districts involved in pilots to introduce this model, under which funding would be sent directly to schools and the school principal, in consultation with the School Planning Council, make all of the staffing decisions. Ms. Hartley noted funding decisions and evaluations would be on a school level and no longer on a collective basis. The speaker expressed concern that repurposing, subsidiarity and student centred leadership lead inevitably to the elimination of elected school boards, collective agreement provisions and any legislation which mandates learning conditions.

Councillor Rankin retired from the Council Chamber at 8:13 p.m.

In conclusion, Ms. Hartley noted that the proposed reorganization will not solve the problem of under funding and urged Council to join with the Burnaby Teachers' Association and the Burnaby School Trustees in contacting and lobbying Burnaby MLAs to provide adequate education funding and reconsider any notion of school based financing.

Councillor Rankin returned to the Council Chamber at 8:18 p.m. and took his place at the Council table.

C) Arden Krystal, Executive Director, Acute Care, and Dr. Tom Compagna, Medical Director, Burnaby Hospital appeared before Council to introduce themselves as new executive leaders at Burnaby Hospital. Both delegates provided Council with

information on their backgrounds and previous experience which have lead them to their current positions in administration.

Councillor Jordan returned to the Council Chamber at 8:22 p.m. and took her place at the Council table.

Ms. Krystal provided information on what has been happening at the Burnaby Hospital over the last year. The speaker advised that programs to meet the diverse needs of the community are being developed based on demographic, noting Burnaby has the second highest proportion of seniors and the highest proportion of seniors living in poverty within the Fraser Health Authority (FHA). Ms. Krystal reported that approximately 70% of the hospital days are made up of people aged 70 years or older. Therefore, they have developed some innovative geriatric programs and have been working on preventative programs in their contracted long term care facilities. The delegate advised Burnaby Hospital also recently opened the first Multiple Sclerosis clinic in the FHA. Ms. Krystal noted the hospital still has one of the best healthy heart and diabetes programs in the Province.

The delegation reported that having recently attended a conference with participants from around the world, overcrowding in emergency rooms appears to be a global problem. The administration will be looking at strategic planning to help alleviate patient congestion in the ER at Burnaby Hospital as well as improving on current processes and services. In conclusion, Ms. Krystal announced the Hospital has just received approval to proceed with to the detailed planning stage for greatly needed renovations to the ER waiting room and triage areas.
