A) Ms. Judith Stone, President, Animal Advocates Society of BC, appeared before Council to speak in support of the principle behind the proposed amendments to the Animal Control Bylaw but also to point out deficiencies in the changes which could lead to different forms of cruelty.

Ms. Stone noted that the bylaw would limit the time a dog can be tethered "unattended" to one hour per day, however, this would not eliminate the dog being a public nuisance (potential for noise and aggressive behaviour), especially if no one is on the property. The speaker noted the proposed bylaw amendment still allows car-lot dogs to be chained all day because staff are always in attendance. Ms. Stone requested staff provide a definition of "unattended" prior to adoption of the bylaw.

Further, Ms. Stone advised the proposed bylaw amendment does not address the issue of yard dogs, particularly those which are caged or penned. The delegate provided Council with a number of photographs of yard dogs and maintains the bylaw will not protect these dogs unless there is a complete ban on yard dogs.

In conclusion, Ms. Stone advised it is a multifaceted problem involving: cruelty; public safety; public nuisance; public expense; public health; and lawlessness. The Animal Advocates Society suggests the solution is a ban on the keeping of dogs outside of the primary building except for one hour per day while attended.

1. Federal Funding Proposal For Multi-Service Hub Facility in Edmonds

Mayor Scott Young raised concerns with regard to the approach taken for funding a regional emergency response team (ERT). The proposal recently came forward but did not provide the opportunity for cities, especially smaller cities, to prepare for the financing in their budgets. Mayor Corrigan noted there was discussion about problems with obtaining new police officers, especially for larger detachments. There were also concerns raised about comparisons being made between municipalities with RCMP detachments vs. municipal police forces as well as the funding formula for the ERT. These regional issues are generating a desire to restart a Mayors' consultative forum with the RCMP which would work to establish a 5 year plan.

WHEREAS Burnaby Lake is in the process of eutrophication with a resultant loss of natural habitat and recreational opportunity; and

WHEREAS the Burnaby Lake Rejuvenation Project Plan will improve the lake's ecological and recreational value thereby preserving the lake as an open water environment and restoring the lost opportunities; and

WHEREAS the majority of the lake rejuvenation work is designed to improve fish access and wildlife habitat, remove lake bed contaminants, restore deeper water to improve lake water temperature and dissolved oxygen and create better shore edge treatment; and

WHEREAS the Burnaby Lake Rejuvenation Project has received a Project Approval Certificate from the Minister of Sustainable Resource Management and the Minister of Water, Land and Air Protection; and

WHEREAS the Burnaby Lake Rejuvenation Project is estimated to cost \$26.5 Million; and

WHEREAS the Project has the support of the GVRD, on behalf of its twenty-one member municipalities, Simon Fraser University and The Federal Minister of Environment; and

WHEREAS the City of Burnaby is prepared to commit one third of the funds required; and

WHEREAS, in May 2005, Premier Campbell announced that the Province of BC will commit up to \$10 Million as part of an equal three-way partnership for the Project;

THEREFORE BE IT RESOLVED: THAT the Federal Government formally commit to providing one-third of the required funding so that the Project may proceed in 2006; and

THAT Prime Minister Martin, leader of Conservative Party Stephen Harper, leader of NDP Party Jack Layton, the candidates running for office in the 23 January 2006 election in the ridings of Burnaby-Douglas and Burnaby-New Westminster and all Burnaby MLA's be sent a copy of this resolution; and

THAT the Federal Candidates be asked to commit and indicate their support to funding this project."

Councillor Evans provided Council with the following notice of motion:

Compensation and Apology For Head Tax Imposed On Chinese Immigrants From 1885 to 1923 and Exclusion of Chinese Immigrants from 1923 until 1946

WHEREAS Canada imposed a discriminatory charge on Chinese immigrants to Canada, commonly referred to as a head tax, between the years of 1885 and 1923;

AND WHEREAS Canada imposed a near total exclusion of Chinese immigrants between 1923 and 1946;

AND WHEREAS Canadians of Chinese origin feel aggrieved by the aforementioned head tax and exclusion; and

AND WHEREAS Canada to date has not apologized for such action or provided any compensation to the affected persons or their descendants;

THEREFORE BE IT RESOLVED: THAT the City of Burnaby call upon the Government of Canada to make amends for these historic wrongs by issuing a formal apology to Canadians of Chinese ancestry and by paying reasonable compensation to those persons directly affected and/or their descendants.

BE IT FURTHER RESOLVED: THAT candidates in the federal election for the ridings located within the City of Burnaby be asked to indicate whether or not they agree that such action should be taken by the Government of Canada.

7. INQUIRIES

Councillor Begin

Councillor Begin referred to a recent Supreme Court ruling permitting consensual sex in private clubs and inquired as to how this might impact Burnaby. Council requested staff provide a memo on Burnaby's stand with regard to this issue and how the City would deal with it should it arise.

Councillor Evans

Councillor Evans referred to a massive explosion and fire involving 20 gasoline storage tanks which took place on 2005 December 12 at a fuel depot near London, England and inquired as to the probability of a similar incident occurring at the Chevron fuel storage depot in Burnaby. He questioned what the likely effect would be on the surrounding neighbourhood in terms of physical damage and air pollution should a similar event occur here. Councillor Evans also inquired as to whether the City has an emergency response plan in place to deal with such issue.

Council requested staff provide Councillor Evans with a copy of the Emergency Response Plan and arrange a meeting with the Fire Chief to discuss the matter.

Councillor Evans referred to a number of recent media articles comparing policing ratios in different British Columbia jurisdictions. Arising from consideration of the matter, Council requested information from staff with regard to policing ratios and RCMP staffing levels.

Councillor Rankin retired from the Council Chamber at 8:50 p.m.

Councillor Calendino referred to a petition he had received from residents in the 4000 block of Georgia Street and inquired as to who it should be presented to. The petition was given to the City Clerk for processing.
