Area residents met with representatives from BC Housing at MLA Richard Lee's office to request BC Housing establish a formal tenants and residents committee to ensure open communication with the community. BC Housing refused this request. The delegation is appearing before Council to request Council to call on BC Housing to create an open channel of communication between the non-profit operators of the facilities and area residents.
