- **Ms.** Melanie Leckovic, RN, Burnaby Hospital Emergency Nurse and Co-Chair, Simon Fraser Region BC Nurses Union appeared before Council to provide an update on the status of patient care at Burnaby Hospital and within the Fraser Health region and suggestions for addressing patient care issues.

Ms. Leckovic advised that funding in the Fraser Health region is not at a level designed to meet the increasing population. On any given day there are 120 unfunded beds in the region as well as 100 – 150 admitted patients waiting in emergency rooms.

In Burnaby there are 19 overflow beds that have been funded by the Fraser Health Authority until the end of March. These beds are staffed by casual staff and are likely to be closed on March 31st.

Ms. Leckovic advised there is no room for surge capacity in the region and therefore if there is a major disaster there are insufficient medical resources to meet the need.

The speaker noted that in the current situation patient safety is compromised; the levels of frustration and burnout among nurses are rising; violence against nurses is at an all time high; more senior nurses are opting to retire and younger nurses are leaving the profession.

In conclusion, Ms. Leckovic recommended four steps to address patient care issues in the Fraser Health Region:

- 1. Provide adequate funding to address population growth through the region.
- 2. Increase the number of long term care beds so that the frail elderly may be moved to appropriate care facilities and away from the acute care environment.
- 3. Increase the number of acute care beds in the Fraser Health Authority to enable quality care for patents in a timely fashion.
- 4. Include frontline nurses in the discussions being held to address the challenges in the Fraser Health Region.

A) Councillor Pietro Calendino Re: World Heritage Site Application

MOVED BY COUNCILLOR CALENDINO: SECONDED BY COUNCILLOR JOHNSTON:

"THAT WHEREAS more than 3000 Watchtowers of historical and cultural value exist in four villages of the Suyi rural areas of China, in the province of Guangdong, sister province to British Columbia, and

WHEREAS 1800 Watchtowers or Diaolou, exist in the Kaiping township alone wherefrom many Burnaby and Lower Mainland Chinese people originate, and

WHEREAS these Watchtowers were built with money sent by overseas Chinese migrants of the last 200 years who met with good fortune in North America and other parts of the world, to project their families and sometimes the whole village from recurrent floods and from frequent incursions by bandits, and

WHEREAS these well preserved, elegant and beautiful Watchtowers form a unique landscape and have a unique Western architectural design sometimes with a blend of Chinese characteristics, and

WHEREAS in 2002 the Government of the Peoples' Republic of China filed an application with UNESCO World Heritage Centre to list the Kaiping Watchtower villages as a protected World Heritage Site, and

WHEREAS UNESCO World Heritage Centre will be meeting in late June of 2007 for consideration of new listings, and

WHEREAS it is acceptable for foreign governments to support application for listing as World Heritage Sites, and

WHEREAS there is a letter of support campaign initiated by MLA's Jenny Kwan and Mike Farnworth who have visited the area and have met with the Kaiping Mayor, and

WHEREAS there is already considerable support from several Chinese organization and from all 3 levels of government, and

WHEREAS Mayor Corrigan has sent a letter to the UNESCO World Heritage Centre,

NOW THEREFORE BE IT RESOLVED THAT Burnaby City Council strongly support the application for listing of the Kaiping Township Watchtowers as a World Heritage Site in order to preserve his jewel of architecture for the world to enjoy.

AND BE IT ALSO RESOLVED THAT a copy of this resolution be sent to UNESCO World Heritage Centre, with copies to the Permanent Delegation of Canada to UNESCO, to Guangdong and Kaiping Governments, and to the office of MLA Jenny Kwan who is maintaining a file to be forwarded to the appropriate authorities."

As Deputy Finance Minister under then Premier Tommy Douglas of Saskatchewan, Mr. Shoyama was one of the key architects of the Canadian medicare system. Mr. Shoyama spent his life in public service contributing greatly to the quality of life of all Canadians and Councillor Volkow publicly acknowledged his many contributions.

Councillor Dhaliwal

Councillor Dhaliwal, with reference to Council Correspondence Package Item (I) from Bill Siksay expressed appreciation for Mr. Siksay's support for the dredging of Burnaby Lake.
