Ms. Alison Pringle, Communications and Special Events Coordinator for PADS, accompanied by "Rex", a Chesapeake Retriever and PADS demonstration dog, appeared before Council to invite Council to attend their 20th Anniversary celebration. On behalf of the PADS volunteers and puppies, Ms. Pringle expressed appreciation to Council for their support of the organization. PADS will be having an 'Open' House on March 24th at the PADS Centre on Stormont Avenue and March 31st is the 20th Anniversary graduation at the Cariboo Fellowship, 7200 Cariboo Road, Burnaby.

Councillor Begin arrived at the Council meeting at 7:05 p.m. and took his place at the Council table.

MOVED BY COUNCILLOR DHALIWAL: SECONDED BY COUNCILLOR JOHNSTON:

CARRIED UNANIMOUSLY

A) O. Moysiuk, appeared before Council to make suggestions on reducing hazards to the environment during house demolitions. Mr. Moysiuk pointed out that he had recently witnessed the entire demolition of a duplex at 7902 Rosewood Street from across the street and noted it was efficiently completed in under four hours.

The speaker listed the toxic substances which could have been left behind:

- a) Mercury: a powerful neurotoxic metal that affects negatively the nervous systems and the brains of humans and other animals. The source of this mercury is from furnace thermostats, refrigerators, stoves, hot water tanks, clothes dryers, mercury thermometers, fluorescent tubes and CFB's (compact fluorescent bulbs). Older Mercury switches are larger and contain more mercury and hence are more polluting when demolished. Mercury is the number one toxic substance in house and duplex demolitions;
- b) Asbestos: found in floor tiles and in old furnace ducts; and
- c) Toxic elements: such as cobalt, lead, chromium, cadmium, bismuth, mercury found in the pigments of paints and varnishes and are present on the walls, doors and furniture of duplexes and houses.

The speaker advised that since he did not know what was in the duplex at the time of demolition he was unable to say exactly what was left behind from the demolition. In closing, Mr. Moysiuk had a number of suggestions with regard to reducing potential hazards associated with demolitions, such as ensuring hazards are confined or removed prior to demolition and wetting down the site so particles aren't carried away in the wind.

Arising from discussion Councillor Volkow was granted leave by Council to introduce the following motion:

B) Hugh Finnamore, #4 – 5400 Patterson Avenue, Burnaby, appeared before Council to discuss mixed-use high density development in Burnaby. The delegation advised that while he supports mixed-use high density neighbourhoods, he strongly opposes single purpose "maximum density" developments because of the consequences for the environment and community. Mr. Finnamore quoted from the Burnaby Economic Development Strategy (EDS) 2020 report stating "these elements of community - social, physical, economic - are interrelated and cannot be treated for long in isolation from each other. Progress in one area, if it comes at the expense of another, does not necessarily make a community better..."

The delegation contends that city planning and revenue generation should be exclusive of one another. The speaker advised that the British Government saw their system for amenity bonuses degrade to the point that, among other regulations, they decreed that Planners should not allow their decisions to be affected by the offer of extra inducements. Mr. Finnamore provided density stats for Vancouver's communities ranging from a low of 6.6 to a high of 137 units per hectare and noted that Burnaby will consider densities of 153 units per hectare or possibly more. The delegation claimed that by allowing development that has the potential to erode neighbourhood stability the potential for property and violent crime increases.

In conclusion, Mr. Finnamore requested that Council put a moratorium on cash for bonused maximum-density projects; rethink its decision to circumvent committee scrutiny and accept cash for circumventing bylaw restrictions; educate Burnaby citizens about the cash for bonus density program and require developers wanting to access bonus density to consult with neighbourhood residents at the beginning of the planning process.

parks/recreation, housing, and social policy, the *Burnaby EDS 2020* presents the City of Burnaby's strategy for improving the local economy. The draft *Burnaby EDS 2020* report puts forward a sound understanding of Burnaby's economic prospects within the regional market context, and proposes practical strategies that have a good chance of success.

The Burnaby Economic Development Strategy (EDS) 2020 Committee recommended:

- 1. THAT Council adopt the fourth generation draft (dated 2007 February 26) *Burnaby EDS 2020* report.
- 2. THAT Council authorize staff to post an electronic version of the adopted strategy on the City's website (www.burnaby.ca) and have 500 hard copies of the document printed.
- THAT Council authorize staff to develop an implementation plan to identify the lead responsibility, recommended processes and/or approaches, and resources required for the actions identified in the *Burnaby EDS 2020* report.
- 4. THAT Council authorize the Mayor to issue a thank you letter and a hard copy of the document to all the representatives of business and not-for-profit community who volunteered their time to sit as either members of the Steering Committee or one of the various Sub-committees.

The two projects recommended in the report are consistent with the tourism action plan contained within the *Burnaby EDS 2020* report.

2. Proposed Amalgamation of Lower Mainland Port Authorities

City of Burnaby staff concur with the recommendations of other municipalities and recommend a number of further issues be addressed including resolution of municipal taxation issues, port land use plans and operational policies.
