A) Ms. Kelly Douglas, owner and director of the Douglas Ballet Academy, 1600 Cliff Avenue appeared before Council outlining issues related to zoning and location of dance studios. The speaker noted she has operated her dance school in Burnaby for the past 15 years and now wants to expand and re-locate her business; unfortunately she has encountered a number of obstacles in finding a suitable location.

Dance studios are required to be located in "C" zoned Commercial sites which generally come with high lease rates, low ceilings and limited open space potential explained the speaker. Ms. Douglas advised that she has contacted several other lower mainland cities and has found many dance schools are located in "M" industrial zoned areas, where the building characteristics address the ceiling height, space and cost issues; in particular the City of Coquitlam has created a special M zone just for dance schools. The speaker also circulated a number of photographs depicting the type of space required to allow a full range of dance education.

Ms. Douglas concluded her presentation by noting, just as youth sports are supported, those families and youth involved in the arts in Burnaby are entitled to the same facilities and opportunities.
