PLAYGROUND DEVELOPMENT FUNDING REQUEST FOR

CHAFFEY-BURKE ELEMENTARY SCHOOL

## **RECOMMENDATIONS:**

- 1. **THAT** the request for a grant of \$3,000 for a playground upgrade for Chaffey-Burke Elementary School be approved.
- 2. THAT a copy of this report be forwarded to Ms Nicole Geyer, Chair of the Chaffe-Burke Elementary School Parent Advisory Council.
- 3. THAT Council be requested to authorize the City to enter into an agreement with the Burnaby School District for the contribution to the cost of the playground upgrade as detailed in this report.

#### REPORT

At its meeting of 2007 June 20, Commission received a request from Ms. Nicole Geyer, Chair of the Chaffey-Burke Parent Advisory Council, for a grant from the 2007 Annual Playground Development Fund for \$3,000. As this was a fourth request for funding, they were placed first on the wait list until 2007 October 01. There has been no first time request for the Playground Development Grant, therefore, the Chaffey-Burke request has been brought forward to Commission for approval.

# **Background on Requests for Playground Development Funds**

The Parks, Recreation & Cultural Services Commission has been providing financial support for the development/re-development of Burnaby elementary school's playgrounds since 1990. Prior to that, the Commission contributed to a school playground only if built on a school site adjacent to a park and only if the playground would contribute to neighbourhood needs. The playground had to be of high enough calibre to be considered in lieu of the playground that would normally have gone on the adjacent neighbourhood park. In 1990 due to multiple requests from elementary schools due to the partial withdrawal of funds from the School Board; the Commission adopted the policy of providing assistance to a maximum of \$3,000 to qualifying schools. Out of the 40 elementary schools in Burnaby, 34 have received funding from the Playground Development Grant.

There is \$9,000 budgeted annually in the Capital Budget and with few exceptions, this entire fund is expended each year. The Playground Development Grant criteria were originally developed to assist with the purchase of playground equipment. In 1999 the playground grant criteria was expanded (Attachment #1) to include the purchase and planting of trees and/or shrubs for the playground area or garden projects. The Burnaby School Board covers the cost to install the equipment; the remaining costs are covered through fundraising by the parent/citizen group.

### Current

Chaffey-Burke Elementary School was placed on a wait list because they had already received three Playground Development Grants over the past 16 years. If this request (Attachment #2) was approved it would make it the fourth grant allocated to this school. At the time, the current criteria stated a school could receive a maximum of three grants. It was acknowledged in the June 2007 report that more schools will be in the same situation as Chaffey-Burke. It was recommended that the criteria be revised and delete the criteria that stated a maximum of three grants allocated to a school. (Attachment #3 Revised Criteria) Chaffey-Burke Elementary School was therefore placed first on the wait list until 2007 October 01. If no other first time requests were received by October 1st, and funds remained in the Capital Playground Development Budget then Chaffey-Burke's request would be brought forward to the commission for approval.

Chaffey-Burke Elementary School meets all the criteria. They have raised sufficient funds and received approval from the Burnaby School Board to install the equipment this year. There are no changes to their initial request in June of 2007. Sufficient funds are available in the 2007 Annual Playground Development budget; there is a balance of \$3,000 for this year.

It is recommended the request from Chaffey-Burke School be approved.

## CRITERIA FOR PLAYGROUND DEVELOPMENT FUNDING REQUESTS

- 1. Funding is available and approved in the Annual Capital Budget.
- 2. The project is initiated and cost shared by a Parent/Citizen Group. The Parent/Citizen Group must have 50% of the project cost raised at the time of the request. The Playground Development grant will provide matching funds up to a maximum of \$3,000.
- 3. Projects are considered on a first come, first served basis. Requests received will be time dated. The first opportunity to submit a request is on the first working day of the new year and then throughout the year.
- 4. The facility will be accessible to the public and thus provide a public benefit beyond serving the school children during school hours.
- 5. That Parks, Recreation & Cultural Services staff be allowed input into the design process.
- 6. That the remainder of the funding for the entire project needs to either be in place or very close to being finalized.
- 7. That a second or third time grant request received within five years of the first approved request is initially placed on a wait list until October 01 of the current year. At that time any requests on the wait list will be reviewed in the order they were submitted. Should funds remain available as of October 01, the applicant making the second or third time request may receive approval for the funding.
- 8. That second or third time requests received after a period of five years be treated on a first come first served basis.
- 9. That a maximum of three grants be provided to any one playground/school site.
- 10. That the maximum contribution for each request is \$3,000.
- 11. That the Burnaby School Board has approved the project and the installation of the playground in that current year.
- 12. That the criteria be expanded to include but not limited to, the purchase and planting of trees and/or shrubs for the playground area or garden projects.
- 13. In the event the Playground Development Fund is completely allocated prior to year end; staff will advise Commission of the grant status and status of grant requests for their consideration.
