Appearing under correspondence on this agenda is a letter from Ms. Karen Agabob, Chair of Stoney Creek Community School Parent Advisory Council. The Stoney Creek Parent Advisory Council is requesting \$3,000 from the 2008 Provisional Capital Budget Playground Development funds to upgrade the school's playground equipment.

The Stoney Creek Community School Parent Advisory Council (P.A.C.) request meets the criteria of the Playground Development guidelines.
