REPORT

The City has had an agreement with the Trustees of the South Burnaby Lawn Bowls Club dating back as far as 1972. They continue to provide a valuable service to the community and to operate within the terms and conditions of their licence.

The conditions of the licence have been reviewed with members of the South Burnaby Lawn Bowls Club, and the following changes are proposed for the new five year term:

- 1. New trustees for the South Burnaby Lawn Bowls Club will be Gerry Scofield and Fran Jeandron.
- 2. Revised mailing address will be South Burnaby Lawn Bowls Club, P.O. Box 72084 Old Orchard Post Office, Burnaby, B.C., V5H 4P9.
- 3. The new term for the licence will be for five years, commencing on the 15th day of April, 2008 and ending on the 14th day of April, 2013.
