REPORT

The Mayor's Task Force on Graffiti, at its meeting held on 2008 October 29, received and adopted the <u>attached</u> report providing an update on implementation of the anti-graffiti strategy adopted by Council in 2007 January. The anti-graffiti bylaw came into effect in 2007 September and the Anti-Graffiti Coordinator has been involved in a variety of enforcement, education, prevention and eradication activities. The Task Force is pleased with the work that has been undertaken to date and recognize that in order to make "Burnaby Beautiful One Tag at a Time" the goals already achieved must be sustained while working towards other objectives and initiatives identified in the strategy. The Task Force noted that Council previously approved extension of the Anti-Graffiti Coordinator position to 2009 June 30.

Given the success of the program to date and the ongoing needs of the program, the Task Force is recommending Council approve the Anti-Graffiti Coordinator position as a regular full time employee.

PURPOSE:

To provide the Mayor's Task Force on Graffiti a progress report on the Anti-

Graffiti Strategy

RECOMMENDATION:

1. THAT the Task Force on Graffiti receive this report for information purposes regarding the Anti-Graffiti Strategy completed by the Mayor's Task Force in January 2007 and adopted by Council in June 2007. The Anti-Graffiti Coordinator was hired to implement the strategy.

REPORT

ERADICATION Graffiti Bylaw/Reporting of Graffiti

Statistics provided are up to 2008 October 21

The Graffiti Bylaw came into effect 2007 September 01. Since inception there have been 384 bylaw notices sent out to the tenants and owners of either business or private properties with 71 outstanding. Since 2008 June, the Anti-Graffiti Coordinator has had Licence Staff assisting with inspections on properties. They are responsible for investigating complaints and bylaw enforcement. The summer months have proven to be extremely busy with complaints and the extra help has been appreciated. There was real focus on Eradication during the spring and summer months.

Parks Staff are very cooperative with graffiti maintenance.

The fight against graffiti on City property has been controlled due to the fact that our departments have been diligent with our fight against graffiti. Continued improvement on the look of our city appurtenances is evident. The occurrence of graffiti has lessened due to the immediate removal of graffiti by City staff.

Bus Shelters are a major target for acid etch graffiti and we are exploring ideas on prevention with other cities in the lower mainland. This has proven to be a very expensive endeavor. Products for this type of removal are clearly needed and will be explored.

The City of Burnaby has a reward program available for information leading to arrest of vandalism on City bus shelters. See more information under Identification and Deterrence.

3rd Party Charges

There has been one property that required the hiring of one of our contractors to remove graffiti off of a business. This process was only directed to the contractor after numerous contacts for the company to remove the graffiti by bylaw notices and also by telephone.

At present there are 5 properties that are not complying with the bylaw and the City is in the process of hiring our contractors to remove the graffiti.

2008 June 21

Hastings Street Graffiti Cleanup/Community Paint out

This was a Community Paint out that was hosted by the District 1 Community Police Station. This event took several days of planning by RCMP and Anti-Graffiti Coordinator.

Posters were set up over the area about the event. Senior member of the Burnaby RCMP and family members volunteered their time.

Local newspapers advertised the event and that brought out extra volunteers.

2008 June 12

City of Vancouver Graffiti Task Force Meeting

Emphasis was on graffiti community paint outs organized by BIA's in Vancouver. Youth volunteer hours were discussed, especially ones that are required for graduation.

2008 June 18

Advertisement Posters and Signs

Burnaby Council, at its Open Council meeting held on 2008 June 16, heard a delegation from Mr. Norm Bacon expressing concern about the overall cleanliness of the City and in particular, the large number of signs and posters littering the City's lamp standards, signal lights and telephone poles. Council introduced and adopted the following motion:

"That the issues raised by the delegation be REFERRED to the City of Burnaby's Anti-Graffiti Coordinator."

The Anti-Graffiti Coordinator is in constant discussion with Mr. Bacon about this issue. City staff is diligently removing signs on a weekly basis.

All victims were present and shared their appreciation to the Metro Town Rotary Club. A donation of fifty dollars was presented to the Rotary Club by one of the victims.

This was a 2 day conference which was hosted by the City of North Vancouver Community RCMP. Guest speakers were from Vancouver, Translink, Vancouver Police, Yonkers New York Police Department, Langford Bylaw, Saskatoon Police, Youth Services North Vancouver.

General discussions were on how graffiti affects our communities.

This year there was a parent who spoke about how graffiti affects a family.

City Of Burnaby Anti-Graffiti Coordinator spoke about the Anti-Graffiti Strategy and the progress of our program to date. Positive comments regarding our Strategy were received along with our Anti-Graffiti Wrap Program.

This symposium is extremely valuable for networking.

PREVENTION

SUPERGRAPHICS ANTI GRAFFITI WRAPS

Council, at the open Council meeting held 2008 March 17, received an Anti-Graffiti Strategy update report and referred the request for use of gaming funds in the amount of \$160,000 for anti-graffiti wraps on traffic control cabinets to the Finance and Civic Development Committee for review.

The Finance and Civic Development Committee, at its open meeting held on 2008March 19, completed its review of this matter and supported the request.

The \$160,000 will wrap all the traffic control boxes in Burnaby.

In consultation with the Planning Department photos were selected to be used in specific neighborhoods in Burnaby.

- Generic photos were chosen for non specific neighborhoods.
- Edmonds Area and City Hall area have historical photos.
- Lougheed Town Centre and Hastings Heights area photos were chosen to reflect business areas.

The summer issue of Information Burnaby had an article about this program and phone calls have been received from all over North America enquiring about the wraps. All the calls have been of a positive nature.

The goal is to have all 230 traffic signals wrapped by the end of October. To date we have wrapped 180 of the 230 boxes.

In addition BC Hydro has contacted the Anti-Graffiti Coordinator to conduct a pilot project in the city. They have agreed to fund 8 of their transformers. The funds will be coming from their Power Smart Program.

Muralist selected and the successful artist is Alex Achtem, an art student at Emily Carr.

2008 June

The mural art decision was made by members of the community, business representatives, city staff and the Heights Merchants Association.

The inspiration of the mural is derived from Russian poster art, depicting epic beams of light cast on a house while a family stands in the foreground.



2008 August 27

The final mural launch was celebrated by the Height Merchants Association and community partners at the corner of Gilmore Avenue and Hastings Street.

2008 September 02

Mural Program with Todd Polich/Environmental Artist

In June, the Anti-Graffiti Coordinator was approached by artist Todd Polich with an idea to create art work of endangered species of CanadaThe artist's ideas were inspirational and staff wanted to do whatever possible to encourage his endeavor which is why it made sense to apply his work to a building that was city owned. The building is addressed 6875 Royal Oak.

Todd's proposal did not include an artist fee as long as the product evolved around endangered species.

The Mural started on 2008 September 02 and the art work was complete on 2008 September 24. The total cost for the mural was \$3350.00. This amount included the cost of equipment rental, paint, supplies and sealant. This cost is a fraction of the price of a regular mural. The wall is ninety feet wide by eighteen feet high

The environmental mural is a pilot project and we are waiting to see if it's a success for deterrence of graffiti. This location is an area where there has been a lot of graffiti.

Plans for additional murals are currently being considered.

2008 August 6-11 Vancouver Restart Program Kitsilano Recreation Centre


Anti-Graffiti Coordinator attending Restart Program and was asked to participate as a member of the community who is affected by graffiti

The purpose of a Restart Program is to create an opportunity for people to explore the impacts and culture of graffiti.

This program provided shared viewpoints on what graffiti means to different realms of society. Three Facilitators who are strictly neutral run the program. The workshop focus is to build trust and security for all parties involved. Considerable collaboration and discussion is part of a successful program. Two artist mentors participated in this restart. Both were past graffiti writers in the Lower Mainland and are now working as Muralists for the City of Vancouver.

Youth involved with the sub-culture attend on a restorative justice basis.

The event took place over 5 days and at the end the participants engage in a mural on city property. The mural is under the Granville Street Bridge.





The Mural theme voted on by the group was the Evolution of Graffiti. You can see the beginning of time in Prehistoric Era and then the evolution of a cave man drawing to a graffiti artist drawing a mural, legally of course. Upon completion of the mural the artists' names are displayed. If the participants are caught doing anymore illegal graffiti, their names are taken off the list. This is a deterrent for the participants. This mural started at 8:00am and finished at 5:00pm.

2008 August 19 ANNOUNCEMENT

RCMP Superintendent announces the hiring of a Burnaby RCMP Anti-Graffiti Coordinator. Expected start date has not been determined. This is exciting news for the Strategy as a fulltime RCMP member will be beneficial in the Identification and Deterrence part of the Anti-Graffiti Strategy. The officer will be working on the enforcement aspect and also the educational piece for law enforcement officers.

FUTURE PLANS

ERADICATION

Continue with enforcement of Graffiti Bylaw.

The Anti-Graffiti Coordinator will continue to work with Public Utility Companies regarding the prompt removal of graffiti.

EDUCATION

In November, the Anti-Graffiti Coordinator is scheduled to attend 5 Parent Advisory Committee meetings to educate parents and teachers on the Anti-Graffiti Strategy. The intention is to visit all elementary schools before June 2009.

IDENTIFICATION AND DETERRENCE Bus Shelters

The Ant-Graffiti Coordinator will explore the reward program for vandalism on City Bus Shelters. The reward for information regarding vandalism is \$500.00

Establishing a Restart Program with Restorative Justice and RCMP

The primary focus is to establish a program where there is restitution of youth who are involved with graffiti. Preliminary discussion with staff has been encouraging. This program is a key part in controlling graffiti in our city.

Burnaby RCMP Anti-Graffiti Coordinator

Continue to work with RCMP on the Identification and Deterrence portion of the strategy. Having an officer to network with regarding this part of the strategy is a crucial part of making this program a success.

Combine and develop new photo database with City of Burnaby and RCMP.

CONCLUSION

The Anti-Graffiti Strategy is well underway with the focus on enforcement over the last 7 months. The next six months will be focusing on building all elements of the Anti-Graffiti Strategy.




New Anti-Graf ti Wrap Program

The City of Burnaby's Anti-Graffiti Strategy is underway and committed to the prevention, deterrence and eradication of graffiti in our community.

As part of this initiative, Council has approved a program to wrap 200 city-owned traffic signal cabinets over this summer. The wraps feature decorative images of Burnaby's gardens and plants with special wraps located in our town centres. This beautification program is intended to deter graffiti and lower maintenance costs as these special vinyl wraps have an anti-graffiti sealant.



Rapid removal is the best form of graffiti prevention






