The Community Development Committee, at its open meeting held on 2008 April 22, received a letter (attachment A) from Metro Vancouver regarding the Metro Vancouver Board endorsement of the Federation of Canadian Municipalities report titled "Sustaining the Momentum: Recommendation for a National Action Plan on Housing and Homelessness." The letter encouraged all municipalities to review the report and consider endorsement of the FCM recommendations.
