- A) Dr. Susan Kwan of the BC Transplant Society provided an overview of *Project Give Life* which is designed to increase awareness of organ transplants in BC and increase the submission of organ donor consent forms across the Province.
  - Mr. Tung Chan, CEO, S.U.C.C.E.S.S. appeared before Council advising this is the 35<sup>th</sup> Anniversary of S.U.C.C.E.S.S., an organization that has helped millions of people who are new to Canada. Mr. Chan advised that this year S.U.C.C.E.S.S. held its annual health fair in Burnaby and expressed appreciation to Council for their support for this event. The delegation provided Council with a copy of their 2007 2008 Annual Report and provided highlights of some of their achievements which included the development of a 50 unit assisted living facility

in Richmond. Mr. Chan suggested that S.U.C.C.E.S.S. would be interested in any opportunity to work with the City to develop an assisted living facility in Burnaby.

Mr. Bill Barrable, B.C. Transplant Society, expressed appreciation to members of the delegation, Mayor Corrigan and City staff person Karly Henney for support of the *Project Give Life* campaign. The speaker provided an overview of the program and outlined the various community events in Burnaby that promoted the organ donor registry donation. Mr. Barrable advised that new technology allows for individuals to provide a digital signature to register online their legal decision regarding organ donation. **Dr. John Yee**, Chair, Medical Advisory Committee, thanked His Worship Mayor Corrigan, Council and the City of Burnaby for support and help in creating donor awareness. WHEREAS the province of British Columbia has committed to reducing GHG emissions by 33% by 2012 and the local governments have a role and responsibility to help meet these targets; and

WHEREAS the British Columbia Motor Vehicle Act Regulations were recently amended to allow electric vehicles to travel on roadways with a speed limit of 50 km/h providing the municipality enacts appropriate bylaws in this regard; and

WHEREAS a number of cities have either passed or are planning bylaws to accommodate electric vehicles;

THEREFORE BE IT RESOLVED THAT Council direct staff to develop a feasibility report on allowing electric vehicles within the City of Burnaby."
