His Worship Mayor Derek R. Corrigan announced he had a special presentation to make to the members of the Gianfranco Giammaria Memorial Society. Mayor Corrigan asked the members in attendance to come forward and presented them with a framed certificate of appreciation for their generous donation to the City of Burnaby of eight Automated External Defibrillators (AEDs), including the required training program. Mayor Corrigan advised that following the sudden and unexpected death of Gianfranco Giammaria during a game of pick-up hockey at 8-Rinks, his wife Denise and some family friends formed the Society. Their goal was to raise money to purchase defibrillators for recreation centres in the lower mainland. AEDs have since been installed in Bill Copeland Arena, Burnaby Lake Arena, Kensington Arena, Eileen Dailly Pool, CG Brown Pool, Bonsor Recreation Centre, Cameron Recreation Centre and Burnaby Lake Sports Complex West. This deployment of AEDs into Burnaby's recreation facilities is one of the largest in any BC community. Mayor Corrigan and Council thanked Denise Giammaria and the members of the Society for their most valuable and life saving gift.

1. Kingsway Pedestrian Overpass

The City Manager submitted report from Director of Planning and Building seeking Council approval for the opening ceremonies of the Kingsway Pedestrian Overpass. The new Kingsway Pedestrian Overpass is a civic amenity that has been accomplished through the City's long-established Metrotown Development Cost Charge (DCC) which was implemented in order to fund the construction of new pedestrian infrastructure projects. The overpass was identified as a key feature of Metrotown's comprehensive urban design and pedestrian plan and its completion now links the north and south commercial areas of the town centre on Kingsway. The overpass provides for a safe, grade separated pedestrian crossing of Kingsway at McMurray Avenue. A second smaller overpass of McMurray Avenue connects the development's commercial and residential components.

The City Manager recommended:

- 1. THAT Council approve an expenditure not to exceed \$5,000 from the Council Committees and Boards' operating budget for the opening ceremony of the Kingsway Pedestrian Overpass, as outlined in this report.
- 2. THAT Council approve the temporary road closure as discussed in this report.

3. Burnaby Immobilization and Towing Bylaw

The City Manager submitted report from Director of Finance informing Council of submissions received in regard to proposed amendments to the Burnaby Vehicle Immobilization and Towing Bylaw. On 2008 June 09, Council received a report from the Licence Office recommending that the Burnaby Vehicle Immobilization and Towing bylaw be amended to have rates for impoundment, storage and drop charges correspond to those found in Section 43.05 of the British Columbia Motor Vehicle Act Regulations. The vehicle release fee or drop charge is applicable when a vehicle owner returns to a vehicle that has been hooked to a tow truck or is in the process of being hooked, but has yet to be removed from the parking spot. The Bylaw includes a drop fee of 50% of the tow charge to cover the costs incurred by the tow operator that reasonably equals half the service required to complete the tow to the tow yard. This drop fee rate has been in effect since bylaw inception in 1993 and is regarded as fair for both the tow operator and consumer.

The City Manager recommended:

4. Unsightly/Overgrown Property at 7320 Canada Way

The City Manager submitted a report from the Director Planning and Building seeking Council authority for City staff to enter the property at 7320 Canada Way, in accordance with Burnaby's Unsightly Premises Bylaw. Since receiving the initial complaint staff has attempted to work with the mortgage holder and his representatives in an effort to achieve voluntary bylaw compliance. Despite two verbal agreements with the representatives, the property remains in contravention of the Unsightly Premises Bylaw and the Licence Office has received further complaints regarding the state of the property.

The City Manager recommended:

1. Council authorize City staff or agents to enter the property at 7320 Canada Way to remove the unsightly overgrowth of weeds, grass and blackberry bushes, remove tree/shrub branches from the ground to the 2 metre level and dispose of used lumber, various debris and litter.
