A) Mr. Iqbal Dhanani, Chair, Burnaby Public Library Board, appeared before Council accompanied by Chief Librarian Edel Toner-Rogala and Board Members Sharon Freeman, Lee Loftus and Andy Chiang to present the 2008 Burnaby Public Library Annual Report.

Mr. Dhanani presented highlights from the Report which included: Sunday openings at all branches; wireless internet access available at all branches; increased number of databases available to patrons; the hiring of their first Teen Services Librarian; and the ground breaking ceremony for the much anticipated Edmonds Library. The speaker noted the 18<sup>th</sup> Annual Pancake Breakfast and Summer Reading Club medal presentation ceremony was a huge success with 750 children and their families in attendance.

Mr. Dhanani expressed his appreciation to retiring Board Members Gary Wong and Ruth Hardy and Council Liaison Councillor Nick Volkow. The delegate took the opportunity to also welcome and acknowledge new members Sharon Freeman and Lee Loftus as well as Council Liaison Councillor Anne Kang.

Mr. Dhanani advised that in 2009, the Summer Reading Program theme is "Follow the Reader" and this year's Pancake Breakfast and Medal Award Ceremony is scheduled to take place on the morning of Saturday, September 12<sup>th</sup>. Also, on the evening of Saturday, June 20<sup>th</sup> there will be a special event celebrating summer's arrival. There will be performances by Children of the Rainbow, a First Nations children's drumming group and Melissa Endean, a Burnaby singer/songwriter.

The speaker advised the library is no longer just a place for books and for keeping your voice down. Today's Burnaby Public Library includes CDs, DVDs, graphic novels, online databases and downloadable books and is more open, more technologically savvy and more community-oriented. In conclusion, Mr. Dhanani expressed appreciation to Council and City staff for their ongoing support and assistance. A copy of the Annual Report is available online at: www.bpl.bc.ca.

**B)** Ms. Elsie Dean, 5285 Empire Drive, Burnaby, appeared before Council on behalf of the BC Seniors Advocacy Network, requesting adoption of the following resolution:

"THAT WHEREAS there are no coordinated seniors' advocacy services funded by any level of government to properly investigate issues and concerns raised by seniors and their families;

AND WHEREAS the seniors' population is increasing dramatically at the same time that government funding cutbacks are severely impacting seniors;

AND WHEREAS this gap in social policy is leading to potential abuse of seniors, causes unnecessary anxiety to seniors and their families, and places additional stress on municipalities;

THEREFORE BE IT RESOLVED that the Union of British Columbia Municipalities support the establishment of an Independent Seniors' Advocate as an officer of the legislature."

Mrs. Dean spoke to various issues concerning the well being of seniors in our society, noting the Independent Seniors Advocate would be a type of "Ombudsman" for Seniors. In conclusion, Mrs. Dean requested Council endorse the resolution and forward it to the UBCM so that it may be debated at the 2009 UBCM Convention.

C) Mr. John Raue, 5668 Chaffey Avenue, Burnaby, appeared before Council to discuss the placement of garbage containers on garbage day when they are placed on the street for collection. Mr. Raue contends the garbage containers take up an inordinate amount of space and pose a safety hazard for both vehicles and pedestrians. The speaker also discussed concerns about dumpster divers who come along and throw garbage around which is not picked up by machines.

Mr. Raue noted Chaffey-Burke School is now 40 years old and, with changes in the area, it is no longer located on Chaffey Avenue, but is now at the corner of Sardis Street and Abbey Avenue. The delegation expressed concerns about seismic upgrading costs, the use of portables and the deterioration of school facilities.

Councillor Volkow rose on a point of order with respect to the issues presented by Mr. Raue as they are related to School Board matters and not City business.

Mr. Raue also addressed an issue related to a fire in a nearby group home where a fire alarm or smoke detector is not operational.

C) Greater Vancouver Regional Steering Committee On Homelessness

Re: Proposed Affordable Housing Resolution For the 2009 UBCM Convention

A letter was received from the Greater Vancouver Regional Steering Committee on Homelessness asking Burnaby City Council to consider endorsing a resolution

on affordable housing for submission to the 2009 Union of British Columbia Municipalities provincial convention.

A staff note advises that in 2008 Burnaby advanced a UBCM resolution 'Calling for a National and Provincial Housing Strategy' which was endorsed by the UBCM membership. In April 2009, the UBCM received a response from the Province which outlined its current housing programs and initiatives. The Province also outlined the actions of Canada's Premiers and Territories to engage the Federal Government on this issue which have failed to achieve any adequate response. Council may wish to endorse the subject resolution being advanced by the Greater Vancouver Regional Steering Committee on Homelessness to the 2009 UBCM provincial convention.

The Affordable Housing resolution provided is as follows:

THAT WHEREAS the provision of and access to affordable housing is vital to support the health and well-being of individuals, as well as the sustainability of vibrant and diverse communities.

AND WHEREAS the changes in senior government funding and the withdrawal of Federal funding for new social housing developments has placed constraints on the construction of new affordable housing units, combined with demand pressures on the existing stock of adequate affordable housing, and ongoing tight rental market conditions has meant that there are nearly 133,100 British Columbians who rent and who are in core housing need.

AND WHEREAS leadership, sustained funding, and strong partnerships are required to increase the supply and diversity of affordable housing across British Columbia.

THEREFORE BE IT RESOLVED that the UBCM urge the Provincial government and Federal government to work with community partners to develop a National Affordable Housing Strategy which includes provisions that respond to the specific needs of British Columbians; and which provides the necessary long-term funding to support the construction of the full range of affordable housing choices needed in communities across the Province;

AND BE IT FURTHER RESOLVED that the UBCM urge the Provincial government to continue to show leadership on this issue through the provision of on-going funding to meet the housing needs in communities across the Province as well as in ensuring that adequate housing and supports are in place to better meet the needs of those who are homeless or at risk of homelessness."

Once the Parks Regulation Bylaw has been amended, it will be necessary to amend the Burnaby Bylaw Notice Enforcement Bylaw to properly cover this circumstance and provide for effective enforcement in the future.

Staff have been asked to submit, as part of the review process, a resolution of Council endorsing the City's applications for two projects: Combined Sewer Separation Program on Capitol Hill and within the Galt Combined Sewer area for a total estimated cost to Burnaby of \$1.75 Million.
