
**REPORT**

Metro Vancouver's current Liquid Waste Management Plan (LWMP) was approved by the Province in 2002 with a requirement for review and updating every five years. In fulfilling this requirement, Metro Vancouver initiated its review in 2007 in collaboration with municipal staff through several LWMP working committees.

The updated Draft LWMP contains carry forward actions from previous plan such as: source control, storm water management, combined sewer overflow management, treatment plant upgrades, and includes new actions to address sustainability needs and resource recovery options.

In accordance with the Provincial requirements, Metro Vancouver has scheduled public consultation meetings to receive input on the draft Plan. The meeting for Fraser Sewerage Area North, which includes Burnaby, will be held on Wednesday, 2009 April 22 at the Executive Plaza Inn, 405 North Rd, Coquitlam, from 7:00 pm to 9:00 pm. It is staff's intent to attend the meeting and report back to the Committee and Council in near future on the draft Liquid Waste Management Plan.
