SUBJECT: BYLAW TO FUND PARKS, RECREATION AND CULTURAL

SERVICES 2009 CAPITAL PROJECTS

RECOMMENDATIONS:

- **1. THAT** the expenditure of \$4,725,000 from the Annual Capital Budget for the projects outlined in this report be approved.
- **2. THAT** Council be requested to bring down a bylaw to appropriate \$4,961,250 (inclusive of 5% GST) from Capital Reserves to finance these projects.

REPORT

The 2009 Annual Capital Budget for Parks, Recreation and Cultural Services contains the following 12 projects to be funded from Capital Reserves. To enable work to go ahead on the following projects, approval is requested to bring down a bylaw for funding.

Regular Program

1. Richmond Park \$150,000

- Complete the master plan, begin demolition and construction of walkways, great lawn, and soft landscape in the north-west area of the park.
- 2. Forest Management \$200,000
 - Continue implementation plans for Capitol Hill and Burnaby Mountain areas including wildfire management, hazardous tree removal, tree planting and tree maintenance.
- 3. Park Fencing Replacement \$125,000
 - Replacement of fencing structures at various locations to include baseball backstops, park fencing, park features and gates throughout the park system.
- 4. Park Safety and Security \$100,000
 - Clearing low branches and underbrush at various park sites and on trails to provide improved site lines for public safety.

5. Picnic Facility Upgrades

\$ 25,000

- Replacement and addition of picnic tables at Confederation, Central, Barnet Marine and Fraser Foreshore Park picnic sites.

6. Park Sites - Equipment Transport Trailers

\$ 30,000

- Ongoing program to upgrade equipment to current safety standards.

7. Spray Pools

\$150,000

- Design and construct the water play feature at Ernie Winch Park.

8. Wading Pools

\$ 85,000

Replacement and upgrades to wading pool decking and fencing.

9. Eileen Dailly Pool

\$ 25,000

Install water conservation devices on showers and fixtures in the changerooms.

10. Eastburn

\$ 75,000

Improvements to the old Kingsway Library building to provide for a temporary site for Eastburn Centre during construction of the new Complex.

11. Cameron Park/Centre

\$160,000

Completion of the three year program to replace the HVAC components at Cameron Centre.

Major Program

1. Burnaby Mountain Golf Course

\$3,600,000

- Construction of the new sixty stall driving range, instruction facility and golf cart storage at Burnaby Mountain Golf Course.

Sufficient Capital Reserves are available to complete the above projects in the 2009 Annual Capital Budget and in the 2010 portion of the 5 Year Capital Plan. Adjustments for the Golf Course Driving Range will be made during the next budget cycle. It is recommended that Council be requested to bring down a bylaw to appropriate \$4,961,250 (inclusive of 5% GST) from Capital Reserves for these projects.
