A) Community Policing Committee Re: Update on the Activities of the Burnaby – New Westminster Task Force on the Sexual Exploitation of Children and Youth

The Community Policing Committee submitted a report providing an overview of recent and planned activities of the Burnaby-New Westminster Task Force on the Sexual Exploitation of Children and Youth. The Task Force has been working since 1998 to address the sexual exploitation of children and youth in the sex trade. While the Task Force has undertaken some projects aimed at improving or expanding services to high-risk youth, and at improving the ability of the police and others to intervene in cases of sexual exploitation, the focus has been primarily on prevention.

The Community Policing Committee recommended:

B) Community Policing Committee Re: Review of Burnaby's Community Policing Model

The Community Policing Committee submitted a report presenting the results of the *Review of Burnaby's Community Policing Model, 1995 – 2007*. Burnaby's Community Policing Model was introduced in 1995 as a vehicle for creating a crime prevention partnership of the RCMP, City of Burnaby, and the community of Burnaby. The review of the model, undertaken in 2007 and 2008, aimed to assess the degree to which the model, as practiced in Burnaby, reflects the principles and objectives originally established for it.

The overall conclusion of the review is that Burnaby's Community Policing Model is working very well and is a success. Select areas where some improvements can be made are identified in the following five recommended areas: Volunteer Recruitment and Retention; Record-Keeping; Burnaby Youth Services Referrals; Police Participation in Multi-Sectoral Problem-Solving Groups; and Community Consultation.

The Community Policing Committee recommended:

- 1. THAT Council endorse the results of the *Review of Burnaby's Community Policing Model, 1995 – 2007,* summarized in this report, and detailed in Attachment 1.
- 2. THAT a letter of appreciation from the Mayor and the Chair of the Community Policing Committee be sent to all members of the Community Policing Model Review Working Group thanking them for their commitment and contribution to the review; and

The Committee firmly believes that early intervention is a key factor is the war against crime.

2. Six Storey Wood-Frame Residential Buildings

- d) Removal of all existing improvements from the site prior to Final Adoption of the Bylaw, but not prior to Third Reading of the Bylaw. Demolition of any improvements will be permitted after Second Reading of the Rezoning Bylaw has been granted, provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse and vandalism.
- e) The completion of the Highway Closure Bylaw.
- f) The completion of the sale of City property.
- g) The consolidation of the net project site into one legal parcel.
- h) The undergrounding of existing overhead wiring abutting the site.
- The granting of Section 219 Covenants restricting the enclosure of balconies.
- j) Compliance with the Council-adopted sound criteria.
- k) The approval of the Ministry of Transportation to the rezoning application.

- The provision of a covered car wash stall and adequately sized and appropriately located garbage handling and recycling material holding space and a commitment to implement the recycling provisions.
- m) The pursuance of Storm Water Management Best Practices in line with established guidelines.
- n) The provision of facilities for cyclists in accordance with Section 4.5 of the rezoning report.
- o) The deposit of the applicable Parkland Acquisition Charge.
- p) The deposit of the applicable GVS & DD Sewerage Charge.
- q) The deposit of the applicable School Site Acquisition Charge.
- r) The submission of a written undertaking to distribute area plan notification forms, prepared by the City, with disclosure statements; and, to post area plan notification signs, also prepared by the City, on the development site and in the sales office in prominent and visible locations prior to Third Reading, or at the time marketing for the subject development commences, whichever is first, and remain posted for a period of one year, or until such time that all units are sold, whichever is greater.

 - h) The review of a detailed Sediment Control System by the Director Engineering.
 - The submission of a geotechnical review regarding the stability of the site to accommodate the proposed development, for review by the Chief Building Inspector and granting of a Section 219 Covenant respecting the submitted report.

j) The deposit of the applicable GVS&DD Sewerage Charge.
