### **REPORT**

In 2003 the Executive Committee of Council approved a process and criteria for receiving and reviewing Golf Tournament Grant requests. Each year the Committee will receive requests from organizations wanting to hold a tournament at the City's Golf Courses for the purpose of raising funds for Burnaby based charities. Received requests are reviewed by staff, and recommendations are then made to the Committee.

Organizing a charity event is an arduous process and requires the establishment of strong relationships and support with the corporate community in order to facilitate sponsorships, donations, and registration in order to be successful in reaching their goals for the community.

Beginning in 1986, this organization has been hosting an annual golf tournament to raise funds for the Burnaby Hospital which serves the residents of this community. This tournament receives tremendous support from local businesses and community members. The contribution of over one million dollars which has been raised at these tournaments has enabled the foundation to purchase innovative health care equipment and technology, and assist in capital projects and educational outreach programs.
