Certificates of Commendation to George Sojka and Russ MacKenzie

Presenters: His Worship, Mayor Derek R. Corrigan and Mr. Rick Makutra

His Worship Mayor Derek R. Corrigan advised Mr. Rick Makutra had written him a letter to advise that last fall, he had been playing a game of squash at Bonsor Recreation Centre when he collapsed

and struck his head as he fell to the floor. He was initially unconscious, had no pulse and was not breathing. Mr. George Sojka was the first staff person to arrive on the scene and began to administer CPR. Mr. Russ MacKenzie assisted with CPR until the Fire Department arrived and took over. Breathing and conscious now the Ambulance Services transported Mr. Makutra to the hospital where he made his recovery. Mr. Makutra stated in his letter "Had it not been for the quick, competent and tireless response I received that day, I would not be alive to write this letter".

On behalf of Mr. Makutra, Council and the citizens of Burnaby, Mayor Corrigan expressed a sense of honour and pride in the actions of Mr. Sojka and Mr. MacKenzie and thanked them both for a job well done.

A) Jack Lavin and Lorne McLeod Re: Blues and Roots Festival Speakers: Jack Lavin Lorne McLeod

A) Mr. Lorne McLeod and Mr. Jack Lavin appeared before Council to discuss the City of Burnaby's Blues and Roots Festival and to provide insight and ideas on this event.

Mr. Jack Lavin, as a long time concert promoter and musician, suggested broadening the appeal of the Festival could increase its profitability. Mr. Lavin advocated for a change in the venue and recommended moving the Festival to the top of Burnaby Mountain to address the current issues with limited parking, access and space, as well as provide incredible sight lines. The delegation shared his ideas of having a 3-ring event providing Canadian Blues singers for adults; an entertainment area for children and an epicurean area featuring BC wineries, breweries and a celebrity chef. The speaker also suggested increasing the merchandising for the event and getting Burnaby's most innovative businesses involved. Mr. Lavin envisions CTV doing a video recording of the Festival for future sales which could be sold and benefits given to local charities. The speaker also noted the City could improve the profile of the event by increasing awareness through the Blues in Schools' program and hiring celebrity MCs. In conclusion, Mr. Lavin proposed that Burnaby would make a beautiful home and perfect tourist destination for a Canadian Music Hall of Fame or a "Music Museum".

Mr. McLeod listed local artists who would be available to perform. The speaker emphasized that Blues is a niche market which doesn't appeal to everyone so broadening the scope could increase profitability. Mr. McLeod believes he and Mr. Lavin have the expertise, desire and knowledge to market this event. The speaker cited other similar events which have been a success and stated their proposal would put Burnaby on the map and keep the money in Canada.

In conclusion, the delegation advised they are a team that could put this together and requested Council give them a chance.

A) Community Development Committee

Re: Community Benefit to be Derived Through Rezoning Reference #09-24, Metrotown Town Centre Development Plan

The Community Development Committee submitted a report to Council recommending a community amenity be derived through a density bonus to Rezoning Reference #09-24 at Bennett Street and Nelson Avenue. Given the strategic location of the site in the Metrotown Town Centre and adjacent to several residential neighbourhoods with high social needs, it is believed that the density bonus presents a unique opportunity to address a broad range of local community needs through the provision of non-profit community programming space. On completion of the preliminary design work, staff would report back to the Committee and Council on the size, design elements, and cost estimates for the proposed community programming space, and seek the necessary approvals for further advancement of the proposal.

The Community Development Committee recommended:

- 1. THAT Council approve, in principle, non-profit community programming space, as outlined in Section 3.1 of this report, as the community benefit to be achieved through a proposed density bonus to Rezoning Reference #09-24.
- 2. THAT Council authorize staff to work with the developer on a preliminary design concept for the proposed non-profit community programming space, as outlined in this report.

Re: Child Care Resources Group Update for 2010

The Social Issues Committee submitted a report providing Council with a summary of activities of the Child Care Resources Group (CCRG) during 2009 and to propose a Work Plan for 2010. During 2010, the CCRG proposes to: co-sponsor an information session for non-profit child care operators on the potential fiscal and quality of care impacts of all-day Kindergarten on child care operations; assist with a staff review of Burnaby's zoning requirements as they pertain to licensed group child care centres in residential zones; and celebrate Child Care Month. The CCRG will also assume its customary role of monitoring changes in the child care environment at the Provincial and Federal levels, and providing advice to the Social Issues Committee and Council on appropriate City responses as necessary.

The Social Issues Committee recommended:

1. THAT Council receive this report for information.

C) Social Issues Committee

Re: Child Care Worker Wages

The Social Issues Committee submitted a report recommending Council support the \$20/hour wage Strategy for Child Care Workers sponsored by the Early Childhood Educators

of B.C. One of the critical challenges to operating a quality child care centre is the recruitment and retention of qualified child care workers. Child care workers are leaving the field, and new workers are not entering it because of low wages, minimal benefits and other factors such as heavy workload, split shifts and lack of prestige associated with the work. With child care fees already consuming a second income in many families, it is not practical to expect that higher wages can be realized through increased child care fees. Staff and the Committee believe that what is required is for the Province to reverse the trend of recent years and infuse the child care system in British Columbia with adequate funding.

The Social Issues Committee recommended:

- 1. THAT the Mayor on behalf of Council, write to the Premier and the Provincial Minister of Children and Family Development urging them to develop a five year plan and funding strategy that moves child care from a user fee system to a universal, publicly funded system, and which supports an equitable entry wage for child care workers.
- 2. THAT the Mayor write to the Prime Minister and the Federal Minister of Human Resources and Skills Development urging them to implement a national child care strategy and work with the Provinces to establish a universal, publicly funded child care system.
- 3. THAT copies of this report be forwarded to Burnaby's Members of the Legislative Assembly and Members of Parliament.

3. THAT copies of these letters be sent to the South Fraser Family Court Committee.

Staff are not aware of any significant changes to the project scope since the last report to Council. It is anticipated that staff will bring forward the outline of a draft Burnaby Access Memorandum for Council consideration in 2010 April.
