B) Ms. Denise Haskett, Executive Director and Community Leader of L'Arche of Greater Vancouver appeared before Council accompanied by Mary Hillhouse, a 23 year resident of L'Arche and Jen Casta, Director of Day Programs.

Ms. Haskett advised she was in attendance at the Council meeting to share information about L'Arche, to thank Council for their support and encouragement and to invite Council to a unique fund raising event entitled "The Art of Being Together" to be held on Saturday, 2010 March 06 at the Nikkei Centre from 1:00 p.m. to 6:00 p.m.

The speaker advised L'Arche was founded by an International Federation in France. Currently there are 135 communities in over 30 countries around the world. L'Arche created communities where persons with developmental disabilities live together with care givers in a family like setting. L'Arche has been in Burnaby for 35 years and has six homes providing housing for 23 adults.

L'Arche also provides two day programs: the first of which provides meaningful work and activities for 15 adults; and the second program called "Neighbour to Neighbour" assists seniors to remain in their own homes.

The delegation expressed appreciation to Council for their support to ensure long term funding for the organization. As a result of Council's support, L'Arche is now looking to the future for new development opportunities.

The final Strategy, which is expected to be presented to Council for approval in 2011 June, will be founded on the City's proud record of past social achievements, will focus on what is practical, achievable and within the City's mandate, and will set direction for a progressive and sustainable social future for Burnaby.
