A) Mr. Dave Teixeira, Pink Shirt Day Communications Director & President of Dave.ca Communications Inc. appeared before Council to help bring awareness to "Bullying Stops Here – Pink Shirt Day" taking place Wednesday, April 14. The speaker thanked His Worship Mayor Derek R. Corrigan for proclaiming the day in the City of Burnaby. Mr. Teixeira provided background information on the origins of Pink Shirt Day and noted they are trying to raise awareness of the campaign and gain participation in other Provinces and States. The speaker encouraged everyone to go to their website: www.pinkshirtday.ca to get more information.

The delegation noted that bullying is a major problem in schools, workplaces and on the internet and outlined the effects of bullying, including low self esteem, absenteeism and victim suicide. Mr. Teixeira noted they are already sold-out of the pink shirts sold in London Drug Stores across Western Canada. The proceeds raised through the sale of the shirts will go to the Boys & Girls Clubs. The speaker noted Mayor Moore from Port Coquitlam had challenged other Council's to all participate. In conclusion, Mr. Teixeira encouraged everyone to wear something pink to symbolize that we as a society will not tolerate bullying anywhere.
