A) Mr. Peter Villella, 7320 Pandora Street, Burnaby, BC, appeared before Council to discuss two areas of concern: wood burning fireplaces and increased aircraft noise. Mr. Villella expressed concern regarding the health issues related to the inhalation of smoke and toxins from wood burning fireplaces. The speaker advised he has taken a number of measures to try to mitigate the smoke from his neighbours' fireplaces entering his own home. Mr. Villella requested the City consider putting limits on wood burning, including restrictions on the number of months wood burning would be permitted. The delegation noted some of his neighbours have also been complaining.

Mr. Villella stated that over the last few years the amount of air traffic over his Burnaby Mountain home has increased significantly resulting in more frequent and constant noise.

In conclusion, Mr. Villella explained his reason for appearing before Council was to bring attention to these matters and to find out there have been additional complaints or if other citizens are aware of these issues.

B) Ms. Paula Farrell, 301 – 6366 Cassie Avenue, Burnaby, BC, appeared before Council to address the issue of street tree planting. The delegation provided the following rationale for street tree planting: beautifies city; provides shade; increases real-estate value/tax base;

environment appropriate for 21st Century; reduces crime; and encourages a sense of community. Ms. Farrell stated the weaknesses of the City's current policy are that there is no capital budget allocation and there is an over reliance on citizen-initiated petitions which have not proven to 'green' the city. The speaker shared her findings which indicated Burnaby is the only municipality out of Vancouver, Coquitlam, Delta and the District of North Vancouver that doesn't have a budget for street tree planting. Ms. Farrell also suggested that Burnaby is the only City in the Lower Mainland which has the Local Area Service Petition (L.A.S.P.) approach for initiating and funding the planting and maintenance of trees on boulevards.

In conclusion, the delegation provided the following suggestions for Council's consideration: provide funds in the capital budget for street tree planting; eliminate or amend the L.A.S.P. process; facilitate departmental communications, with planning for professional best practices; and take advantage of Access grants and other funding which may be available to the City.

Arising from consideration of delegation's presentation, Councillor Jordan was granted leave by Council to introduce the following motion:

Corrigan write to the Mayors' Council, TransLink and the Minister of Transportation requesting work on the Evergreen Line not commence until all of the required financing is in place and without placing further burden onto taxpayers and THAT the Cameron Station be reinstated on the Evergreen Line" **AS AMENDED** and same was CARRIED UNANIMOUSLY.

Councillor Dhaliwal

Councillor Dhaliwal made reference to Item H) of the Council Correspondence received to 2010 July 09 from Brian Bonney, Director of Provincial Affairs, Canadian Federation of Independent Business regarding their Annual 2010 Property Tax Report.
