- A) Ms. Harriet Tuey, Burnaby Torch Relay Coordinator and Co-Chair, Burnaby Spirit of BC Community Committee, Mr. Matthew Coyne, Burnaby Spirit Co-Chair and Executive Director, Tourism Burnaby and Ms. Pat Carlsen, Burnaby Spirit Secretary and Tourism Manager, Metropolis at Metrotown, appeared before Council advising of the events planned in conjunction with the 2010 Torch Relay. Ms. Tuey stated there will be a "photo op" stop at the Burnaby Village Museum on Thursday, 2010 February 11 with a Burnaby Community Celebration to follow at Metropolis at Metrotown's Grand Court from 2:00 p.m. until 7:00 p.m. The delegation invited Council and the public to attend the Celebration. Ms. Tuey informed Council they were unable to divulge the actual touch route at this time as this information is being held confidential until 10 days prior to the event.
- B) Mr. Ivan Hnatuik, 4253 Albert St, Burnaby and Mr. Peter Cech, appeared before Council to discuss the "Transportation Review of Burnaby Heights/Capitol Hill Neighbourhood" report (Report 4 (F) from the City's Transportation Committee). Mr. Hnatuik advised

Council he had had the opportunity to appear before the Transportation Committee last week to address the following concerns with the report:

- 1. Speeding there is no reference to speeding on Albert Street as staff consider speeders to be insignificant;
- 2. Stop signs the problem with drivers not stopping at the stop signs is not mentioned in the report;
- 3. Volume Albert Street currently has about 5,600 vehicles on it each day which is more than the street is designated for;
- 4. Regional traffic staff has not verified the numbers of regional trip vehicles;
- 5. Oversized commercial vehicles some of these large vehicles are currently using Albert Street in order to avoid Hastings Street even though it is not their shortest route;
- 6. Enforcement not addressed in the report; and
- 7. Previous efforts there have been numerous measures taken in the past with limited or no success to resolve the traffic issues in this area.

The speaker suggested what was also missing from the report was the human factor. Mr. Hnatuik requested the sentence "Based on the above, staff would not propose to pursue the use of diversionary methods" be struck from Section 3.5.1 of the report as it appears to be at odds with the amendment made by the Committee after their presentation. Section 4.2 point 7. states "In addition to the above, the Transportation Committee, at its meeting of 2010 January 13, invited the public to offer other traffic calming measures, including diversions and barriers, to reduce Regional Trips and traffic speed in the neighbourhood". The delegation requested staff map out what diversionary measures might look like.

**Mr. Peter Cech** thanked the members of Council who sit on the Transportation Committee for their willingness to look at diversions and encouraged more open discussions with the neighbourhood on this issue.

C) Ms. Hinda Abdillah, 116 – 3993 Henning Drive, Burnaby, BC, and Ms. Laverne Kelly, appeared before Council to discuss the process involved with obtaining a business licence from the City for Ms. Abdillah's business, Hinda's Finest Food.

The speaker advised she moved to Burnaby from Vancouver in 2009 July and it took until 2009 December to obtain a licence. Ms. Abdillah stated this delay caused her to be in a difficult financial situation and expressed her lack of understanding as to why it took so long for her to get her business licence.

His Worship, Mayor Derek R. Corrigan explained he had reviewed information on the process undertaken by staff and emphasized the City could not issue the business licence until the new location had met the standards required by the Fraser Health Authority for food processing.
