- A) Ms Cheryl Ping Wong, of 8133 Fifteenth Avenue, Burnaby, appeared before Council accompanied by Ms. Joyce Li, to request Council rescind or not proceed with the Notice on Title on her property. The delegation is promising not to rent out the renovated garage area.
- **B)** Mr. Joseph Oh, 7366 Montecito Drive, Burnaby, BC, appeared before Council to discuss traffic safety in his north Burnaby neighbourhood. Mr. Oh referred to maps distributed to Council prior to the meeting noting that Montecito Drive is designated as a road not a major collector.

The speaker discussed the growth in the area which has resulted in increased traffic flow. He noted traffic, instead of using area collectors, travels south on Phillips Avenue and then west

onto Montecito Drive. His primary concern is the speed of traffic, particularly when an elementary school is nearby.

Mr. Oh reviewed the traffic calming measures applied by the City on Cliff Avenue, Kitchener Street, Gibson Street and Fell Avenue, while noting that there have been no traffic calming measures on Montecito Drive. The speaker also provided pictures of accidents, skid marks and tree damage occurring along Montecito Drive as a result of high speed traffic. Mr. Oh also expressed concerns about the volume of heavy truck traffic using Montecito Drive.

In conclusion, Mr. Oh requested Council consider speed humps, a centre median and a round about to control traffic on Montecito Drive and invited Council to visit Montecito Drive during rush hour to see traffic speeds and volumes.

C) Mr. Chuck Puchmayr, 1107 Nanaimo Street, New Westminster, BC, appeared before Council to encourage people to become organ donors. As a 14 month liver transplant survivor, Mr. Puchmayr knows the value of registering as an organ donor in BC. The speaker stated there is a critical shortage of donors in BC and informed Council the cost of a kidney transplant is \$20,000 compared to \$50,000 for life long dialysis. Also there were 29 liver transplants in 2009; 16 Burnaby citizens are currently waiting for donation; 24,000 people in Burnaby registered for organ donation.

Mr. Puchmayr suggested one of the drawbacks to organ donation is the fear that organs may be harvested early or that treatment would be withheld because someone is on the donor registry. Mr. Puchmayr assured that this is not the case and that organs are only harvested once a patient is declared clinically dead.

In conclusion, the delegation advised that to join the donor registry citizens should go to transplant.bc.ca and click on the link to donate, put in their name and care card number or call 1-800-663-6189 and you are registered. There is no age restriction. Mr. Puchmayr noted that the City of New Westminster includes organ donor documentation with the mailings for the utility bills.
