LOCHDALE COMMUNITY HALL ASSOCIATION LICENSE RENEWAL

RECOMMENDATIONS:

- 1. **THAT** approval be given for the renewal of the license agreement with the Lochdale Hall Community Association, for a further five year term beginning the 1st day of July, 2010; with minor revisions to the terms and conditions as outlined in this report.
- 2. THAT Council be requested to concur.

REPORT

The City has had an agreement with the Lochdale Community Hall Association for at least sixty-five years. The Association is responsible for operating the Lochdale Community Hall, including maintaining the interior of the facility for reasonable wear and tear. The Association manages this heritage resource and makes it available to the community for a cost recovery fee, with payment of \$1 per year to the City. The Association continues to provide a valuable service to the community, by way of their management and operation of the Hall, and they continue to operate within the terms and conditions of their license.

The terms of the license have been reviewed with the Association, and the following changes are proposed for the new five year term:

- 1. The new term for the license will be for five years commencing on the 1st day of July, 2010 and ending on the 30th day of June, 2015.
- 2. Insurance requirements have been updated to comply with City standards.
- 3. The list of equipment owned by the Association has been updated.
