A) Ms. Cathie Heritage, Executive Director, Ms. Ruth Hellerud-Brown, Community Health Specialist and Ms. Nadine Lowen, Mental Health Officer, Fraser Health, appeared before Council to present an overview of the Healthier Community Partnership with the aim of formalizing a partnership between Fraser Health and the City of Burnaby. The speakers also presented an outline of the proposed format for a 2011 Healthy Living Trade Show and wished to confirm whether the City is willing to host the Trade Show.

The delegation provided video and power point presentations on the Healthier Community initiative which showed how Fraser Health and municipalities can collaborate to encourage healthy eating, physical activity and tobacco free living. These partnerships represent an opportunity to move the focus of "health" from treatment and remediation to promotion and prevention through immediate action.

The delegation concluded by advising that the proposed 2011 Healthy Living Trade Show will highlight healthier living initiatives undertaken by municipalities and serve as a forum for the exchange of ideas.

A community benefit valued at \$7,393,990 will be derived through the rezoning. The site for the subject multi-family residential project is not considered appropriate for an on-site amenity.

subject properties. The Committee noted the previous consultation process for the subject properties was completed but not advanced because it did not meet Council adopted criteria for adequate property owner support. However, this new request for the R12S District is substantially different than the previous R12 District and the potential build out under the R12S zoning is much less than that under the previous R12 zoning proposal.

The zoning bylaw amendments address side and rear yard setback provisions for commercial or industrial developments adjacent to a Comprehensive Development District site, and regulation of business establishments for the purchase of gold, silver and other precious metals.

Pedestrian crossing reviews were undertaken along Arcola Way/Street at Salisbury Avenue, Hall Avenue and Walker Avenue. All three locations did not meet the warrant for marked crosswalks. Although Salisbury Avenue and Arcola Way did not meet the criteria, due to nearby bus stops, a marked pedestrian crosswalk has been recommended on the south leg of the intersection to enhance pedestrian safety.

Installation of a full traffic signal is not supported and the installation of a full traffic signal is not advantageous for pedestrians. However, the installation of an additional street light at the southeast corner of the intersection is recommended to improve night time visibility of pedestrians as well as installation of a sidewalk curb ramp at the southwest corner to make the entire intersection wheelchair accessible.

3. Rezoning Reference #10-29 High-Rise Apartment Tower with Street Fronting Townhouses Metrotown Development Plan – Sub-Area 6

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2011 June 28. The purpose of the proposed zoning bylaw amendment is to permit the construction of a high-rise multi-family residential development with street-fronting townhouses.

The City Manager recommended:

- 1. THAT the introduction of a Highway Closure Bylaw be authorized according to the terms outlined in Section 3.2 of this report, contingent upon the granting by Council of Second Reading of the subject Rezoning Bylaw.
- 2. THAT the sale be approved in principle of City-owned property at 6565 Dunblane Avenue for inclusion within the subject development site in accordance with Section 3.2 of this report, and subject to the applicant pursuing the rezoning proposal to completion.

3. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2011 June 13, and to a Public Hearing on 2011 June 28 at 7:00 p.m.

- 4. THAT the following be established as prerequisites to the completion of the rezoning:
 - a) The submission of a suitable plan of development.
 - b) The deposit of sufficient monies, including a 4% Engineering Inspection Fee, to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All services are to be designed to City standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
 - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d) The utilization of an amenity bonus through the provision of a \$7,393,990 cash in-lieu contribution in accordance with Section 3.3 of this report.
 - e) The consolidation of the net project site into one legal parcel.
 - f) The granting of any necessary Covenants, including, but not necessarily limited to, Section 219 Covenants restricting the enclosure of balconies, indicating that project surface driveway accesses will not be restricted by gates, guaranteeing provision and maintenance of public art, and providing that all disabled parking to remain as common property.
 - g) The granting of any necessary easements and statutory rights-of-way.
 - h) The dedication of any rights-of-way deemed requisite.
 - i) The design and provision of units adaptable to persons with disabilities (the provision of special hardware and cabinet work being subject to the sale/lease of the unit to a disabled person) with allocated disabled parking spaces protected by a Section 219 Covenant.
 - j) The provision of covered car wash stalls and adequately sized and appropriately located garbage handling and recycling material holding space to the approval of the Director Engineering and a commitment to implement the recycling provisions.
 - k) The submission of a suitable on-site stormwater management system to the approval of the Director Engineering, the deposit of sufficient

monies for its provision, and the granting of a Section 219 Covenant to guarantee its provision and continuing operation.

- 1) The deposit of the applicable GVS & DD Sewerage Charge.
- m) The deposit of the applicable Parkland Acquisition Charge.
- n) The deposit of the applicable School Site Acquisition Charge.
- o) Completion of the sale of City property.
- p) The provision of facilities for cyclists in accordance with this report.
- q) The undergrounding of existing overhead wiring adjacent to the site.
- r) Compliance with the Council-adopted sound criteria.
- s) The review of a detailed Sediment Control System by the Director Engineering.
- t) Compliance with the guidelines for underground parking for visitors.
- u) Completion of the Highway Closure Bylaw.
- v) The submission of a written undertaking to distribute area plan notification forms, prepared by the City, with disclosure statements; and, to post area plan notification signs, also prepared by the City, on the development site and in the sales office in prominent and visible locations prior to Third Reading, or at the time marketing for the subject development commences, whichever is first, and remain posted for a period of one year, or until such time that all units are sold, whichever is greater.
