

#### COUNCIL REPORT

**PURPOSE:** To seek Council's approval to update the Burnaby Bylaw Notice Enforcement Bylaw.

## **RECOMMENDATION:**

**1. THAT** Council authorize the preparation of the necessary bylaw amendments to the Burnaby Bylaw Notice Enforcement Bylaw, as outlined in this report.

## REPORT

## **1.0 INTRODUCTION**

At the regular Council Meeting of 2009 March 09, Council authorized a ticketing bylaw for the City.

On 2009 June 15, Bylaw No. 12657, the Burnaby Bylaw Notice Enforcement Bylaw, was adopted by Council and early in 2010 staff began issuing tickets using the new bylaw.

In the report dated 2009 March 09 which recommended the preparation of the bylaw, it was noted that once the bylaw was in place that future amendments may be required from time to time. As such, this report proposes a number of additional offences from a variety of bylaws to be included in the Burnaby Bylaw Notice Enforcement Bylaw. It also proposes that a number of offences be removed from the bylaw and that several new positions be added to the list of designated Screening Officers and Bylaw Enforcement Officers.

## 2.0 AMENDMENTS TO SCHEDULE "A" OF THE BYLAW

Schedule "A" of the Burnaby Bylaw Notice Enforcement Bylaw lists all of the sections of all of the bylaws which can be enforced using bylaw notices and specifies the fines for those offences.

*Attachment "1"* of this report lists additional offences from the Building, Plumbing, Cab, Noise, Parks and Solid Waste and Recycling Bylaws for inclusion in the subject bylaw. It is proposed that these new offences and the related fines be added to Schedule "A" of the Burnaby Bylaw Notice Enforcement Bylaw.

The Burnaby Solid Waste Bylaw 1981 has been replaced by the Solid Waste and Recycling Bylaw 2010. It is proposed that all of the offences related to the previous "Burnaby Solid Waste Bylaw, 1981" be removed from Schedule "A" of the Burnaby Bylaw Notice Enforcement Bylaw. Offences related to the new Bylaw are proposed for inclusion in Schedule "A," as indicated in *Attachment* "1."

## 3.0 SCREENING OFFICERS AND BYLAW ENFORCEMENT OFFICERS

Screening Officers review all disputed bylaw notices before a dispute adjudication is scheduled. Section 8 of the Bylaw Notice Enforcement Bylaw designates classes of persons appointed as Screening Officers. It is proposed that a number of additional classifications of City employees and agents be included in the list of appointed Screening Officers. They include the RCMP, the Burnaby Branch Manager of the SPCA, the City's Engineering Inspectors, the Manager of Public Works and the Environmental Engineer.

The Bylaw also specifies a Bylaw Enforcement Officer position which is authorized to issue bylaw notices. Section 10 of the Bylaw designates classes of persons appointed as Bylaw Officers. It is proposed that a number of additional positions be included in the list of appointed Bylaw Enforcement Officers. They include the Chief Licence Inspector, Manager of Public Works, Environmental Engineer and the City's Engineering Inspectors.

## 4.0 CONCLUSION

Burnaby's new Bylaw Notice Enforcement program is working well. Several adjudication hearings have been successfully completed and staff are continuing to improve and refine the program. Recent changes to several City bylaws have introduced new language and new contraventions which staff propose be added to Schedule "A" of the Bylaw Notice Enforcement Bylaw. After working with the new program, staff have also identified contraventions from various bylaws that were not included in the original list of offences. These additional offences lend themselves to enforcement using the bylaw notices and are proposed to be added to the list of contraventions, along with additional City positions for the Screening Officer and Bylaw Enforcement Officer functions.

In order to keep our Bylaw Notice Enforcement Bylaw current with our other regulatory bylaws, it is recommended that Council authorize the preparation of the bylaw amendments, as outlined in this report.
