- 2. THAT Council forward a copy of this report to the Honourable John Duncan, Minister of Indian Affairs and Northern Development and Federal Interlocutor for Métis and Non-Status Indians; the Burnaby Members of Parliament; the Honourable Mary Polak, Minister of Aboriginal Relations and Reconciliation (MARR); the Burnaby Members of the Legislative Assembly; and Mrs. Agnes Rosicki, Managing Director, Lower Mainland Treaty Advisory Committee (LMTAC).
