### **PRESENTATION**

### Donation of Oil Painting to the City of Burnaby Presenter: Juan Contreras

### Award from Association of Professional Engineers and Geoscientists of BC for Burnaby Lake Project

His Worship, Mayor Derek R. Corrigan, advised the City Burnaby received the 2011 Association of Professional Engineers and Geoscientists of BC Award in the category of *Outstanding Achievement in Environmental Design, Construction and Monitoring* for the Burnaby Lake Restoration Project. City staff reviewed five submissions in response to an RFP for the deployment of three ATM machines at City facilities. It was determined that while revenue sharing was a factor in

deploying the ATM units, customer service and convenience are the primary drivers of this service. The deployment of ATMs from G&F Financial Group provides free ATM services to Credit Union and HSBC clients while charging a convenience fee for clients from Canada's five major banks such as CIBC, RBC and BMO. The convenience fee is less expensive than the fee charged by white label ATM providers who would charge a fee to all users.

This report has proposed two projects as the basis for the City's 2012 application to TransLink for capital cost-share funding on the Major Road Network. The proposed projects are signal coordination on Kingsway and the balance of funds required for the rehabilitation and seismic upgrade of the Gaglardi Way overpass. Individual project expenditure authorization for these projects would follow Council approval of the 2012 Provisional Capital Program and receipt of confirmation of the subject MRN cost-share funding.

The Transportation Committee recommended:

# 1. Application for Cost Share Funding BC Hydro Beautification Program - 2012-2013

Participation in the BC Hydro Beautification Program has provided one-third cost sharing for various City underground wiring projects. Staff have identified four potential projects for consideration. Three are adjacent to City lands in the Central Administrative Area and Deer Lake Park. An additional project on Gilmore Avenue adjacent the City's Jim Lorimer Park has also been identified.

The City Manager recommended:

1. THAT staff be authorized to submit an application to BC Hydro for cost share funding under the Beautification Program, as outlined in this report.
