 - Annual cost savings of \$1 \$3 million in operating expenses.

The speaker also noted the existing buses are too crowded and the gondola would run more hours per day than the buses. In addition, the speaker presented a letter from the Simon Fraser Sustainability Association supporting the gondola project. The letter noted travel time to campus would be reduced by over 50% and poor winter road conditions would no longer necessarily result in closure of the campus. The letter further noted this proposal would help to improve air quality and reduce transportation related pollution. The speaker concluded by requesting Council support the gondola project.

Re: Official Sister City Visits

Zhongshan, China – September 18 – 19, 2011

Hwaseong, South Korea – September 22 – 24, 2011

His Worship, Mayor Derek R. Corrigan submitted a report advising Council of the delegations visiting from Zhongshan, China and Hwaseong, South Korea. The purpose of the eight member delegation from Zhongshan City, including Ms. Han Zesheng, Vice Mayor, is to sign a Sister City Agreement between the two cities. This short visit will fulfill the obligation of the Memorandum of Agreement between the two cities to work towards developing a more beneficial, meaningful and long-lasting relationship.

The City of Burnaby entered into a Sister City relationship with Hwaseong, South Korea during a visit to Hwaseong in 2010 September. On September 22, 2011 a seven member delegation, led by Mayor Chai, In Seok will arrive in Burnaby for its first official visit providing an opportunity to showcase the highlights of the City of Burnaby and discuss future opportunities in the areas of tourism, economic development and international education exchanges between the two cities.

The combined cost of hosting both official visits is estimated at \$14,500.

His Worship, Mayor Derek R. Corrigan recommended:

Greater financial impacts on the City's water rate primarily relating to future Metro Vancouver water supply costs and infrastructure replacement are expected for the next 15 years. Staff will continue to work with Metro Vancouver towards developing and delivering a more sustainable water supply plan.

- e) The completion of the Highway Closure Bylaw.
- f) The completion of the necessary subdivision survey plan.

AND WHEREAS B.C.'s local governments shoulder significant economic, cultural and environmental risk in the event of a large oil spill into their watershed(s) or the marine environment near their communities;

AND WHEREAS B.C.'s local governments have not been actively consulted regarding Kinder Morgan's historic or planned expansions of oil tanker traffic:

THEREFORE BE IT RESOLVED that the UBCM request that the National Energy Board and Federal Ministers of Environment, Natural Resources, and Transport commit that any further application by Kinder Morgan to expand the amount of oil transported by pipeline and tanker utilize the highest degree of environmental assessment and consultation available, with full opportunity for local government participation,'

be **RESCINDED**."

THEREFORE BE IT RESOLVED that the UBCM request that the National Energy Board, Port Metro Vancouver, and all appropriate Federal Ministers ensure that any application to expand the amount of oil transported by pipeline and tanker undergo:

- a) the highest degree of environmental assessment; and
- b) meaningful public consultation, including direct engagement with affected municipalities, regional authorities and B.C. First Nations."
