A) Ms. Chantel Mousseau, a member of Youth Voice, a subcommittee of the Burnaby-New Westminster Task Force on Sexual Exploitation of Children and Youth and Ms. Stephanie Docherty, Co-ordinator, Student Safety and Child Abuse Prevention for the Burnaby School District, appeared before Council to raise awareness regarding the very serious issue of sexually exploited children and youth in the community. The delegation noted education is an important component in the struggle to eliminate the underage sex trade. The delegation shared a video regarding this topic and noted that governments must create laws with a zero tolerance for all forms of sexual exploitation.

The delegation concluded by advising the 2nd Annual 5 km walk/run to raise awareness about the sexual exploitation of children and youth in Burnaby and New Westminster. The event will be held on Sunday, March 13, 2011 at Central Park. Funds raised will go towards event costs and to agencies supporting youth victims of sexual exploitation.

A) Environment Committee

Re: 2011 Environment Week and Environment Awards Program

Street Hockey Tournament 2011

The City Manager submitted a report from the Director Parks, Recreation and Cultural Services seeking Council approval for road closures for the "Play On! Burnaby" Street Hockey Tournament 2011. This tournament will be held 2011 June 11 and 12 in the Metrotown area and will require temporary closure of the eastbound lane of Central Boulevard from Willingdon Avenue to Bonsor Avenue and a section of Bonsor Avenue.

2. Licence Agreement – Burnaby Sailing Association

The Burnaby Sailing Association is a not-for-profit small craft sailing and paddling organization that has been in continuous operation at Barnet Marine Park since the late 1970's. They do not have a current formal licence agreement for the occupation of the compound in the park; however, it is recognized in the Barnet Marine Park Master Plan as an activity that is appropriate to this particular park.

The City Manager recommended:

1. THAT approval be given to enter into an agreement with the Burnaby Sailing Association for a five year term beginning the 1st day of March 2011 and ending on the 29th day of February, 2016 under the terms and conditions in the attached report.
