SUBJECT: PLAYGROUND DEVELOPMENT GRANT REQUEST FOR BRENTWOOD PARK ELEMENTARY SCHOOL AND WESTRIDGE ELEMENTARY SCHOOL

RECOMMENDATIONS:

- **1. THAT** the requests from Brentwood Park Elementary School and Westridge Elementary School be approved.
- 2. THAT a copy of this report be forwarded to Ms. Becky Liu, Co-Chair of Brentwood Park Elementary School Parent Advisory Committee and Ms. Deborah Smart, Co-Chair of Westridge Elementary School Parent Advisory Committee.
- **3. THAT** Council be requested to authorize the City enter into an agreement with the Burnaby School District for the contribution to the cost of the playground upgrades as detailed in this report.

REPORT

Appearing on the agenda is correspondence from Ms. Deborah Smart, Co-Chair of Westridge Elementary School Parent Advisory Committee and Ms. Becky Liu from Brentwood Park Elementary School Parent Advisory Committee. The Parent Advisory Committees (PAC) are requesting a grant from the 2011 Annual Operating Playground Development budget to assist with the redevelopment of their playgrounds.

Background

There is \$9,000 budgeted annually in the Operating Budget and, with few exceptions, the fund is expended each year. The Playground Funding Requests criterion is attached (<u>Attachment #1</u>). At the 2011 January 19 Commission meeting, Commission approved an additional \$9,000 for 2011. The increase to the grant was agreed to because of the number of requests for funding. There is now a total budget of \$10,440 in the playground development budget. Five schools have been placed on the wait list as they are making a second time request for funds within five years.

Current

Both Westridge Elementary School and Brentwood Park Elementary School meet the Playground Grant guidelines and are applying for funding on these projects for the first time. There has been approval from the Burnaby School Board to install both playgrounds in 2011.

Outlined below is the cost breakdown for each school's playground grant request:

Westridge Elementary School

Total cost of re-development for 6 seat swing	\$ 3,509.75
Funds raised to date	<u>\$ 2,000.00</u>
Amount requested from Playground Development grant	\$ 1,509.75
Brentwood Park Elementary School	
Total cost of re-development for play components *	\$36,000.00
Funds raised by PAC to date	\$24,400.00

Amount requested from Playground Development grant \$ 3,000.00

* School would like to purchase wheelchair accessible play components.

It is recommended that Westridge and Brentwood Park Elementary Schools Parent Advisory Committee requests be approved. If approved there will be **\$5,930.25** remaining in the 2011 Playground Development budget.
