Councillor Paul McDonell introduced the Local Heroes Program and thanked the nominators for their contributions to the program.

His Worship, Mayor Derek R. Corrigan presented each of the Local Hero Award recipients with a framed certificate of appreciation while Councillor Paul McDonell provided the following brief summaries of the recipients' personal contributions over the past years:

**Darlene Gering:** Darlene is an energetic and vital force in the Burnaby community. In addition to going above and beyond her mandate during her time as President and Chief Executive Officer of the Burnaby Board of Trade to advocate for and participate in a wide range of community development initiatives, Darlene also contributes to her community through volunteer work. Among other roles, Darlene has been involved as a volunteer with Faith Lutheran Church for over 10 years, where she assisted in negotiating the expansion and joint ownership of the church building with the Vancouver Chinese Lutheran Church. In addition, Darlene volunteers with the Burnaby Art Gallery as a member of their Leadership Advisory Committee, where she has been key in advising on acquisitions and fundraising initiatives. Darlene also volunteers her time with Burnaby Family Life, the Burnaby Intercultural Planning Table, and the Burnaby Taskforce on Homelessness.

**Stephen Hughes:** Stephen has been an active volunteer with the City's Citizen Support Services for over 15 years. In this capacity, Stephen has been involved with the 'Volunteer Visitor' and 'Phone Buddy' programs, which reach out to isolated individuals in the Burnaby community. Through his role in these programs, Stephen has worked to ensure the participants' well-being and to provide support for their becoming involved in additional programs and activities. Stephen has also been very involved with his church and the Burnaby Host Lions Club for many years in a number of supportive roles.

**Vicky Ma:** Vicky has been volunteering her time and skills at both Edmonds Community School and Suncrest Elementary in Burnaby for over five years. In this time she has made many contributions including volunteering in two classrooms coordinating the 'Fruit and Veggie' program, heading the Grade seven video club, assisting with Kindergarten orientation, and helping to organize the Grade seven graduation. Vicky has also served on her local District Advisory Council as a representative, treasurer, and childcare coordinator for parental events. Outside of her activities with the School District, Vicky is also a committed volunteer with the Immigrant Services Society of BC and with a martial arts association.

Raymond McKay: Raymond has been an active volunteer in the Burnaby community for many years. Since 2001, Ray has served on the Board of Directors at the Burnaby-based Community Centered College for the Retired, while also instructing two classes in Bridge. As well, Ray is the volunteer manager of the 'Moody Blues', a division of the Lower Mainland Seniors Slo-Pitch League, and is committed to encouraging seniors to stay active and be healthy. In addition to these roles, Ray volunteers with the Company of Master Marines in Canada (Ray served with the Merchant Marine during World War II), with his church, and with the Knights of Columbus in Burnaby.

Jim McQueen: Jim gives many hours of volunteer time to participate in a wide range of initiatives in his community. Among other activities, Jim is a member of the Southeast Burnaby Community Policing Advisory Committee, working to bring a citizen's perspective to policing issues. As well, Jim has been a regular volunteer at the Progressive Housing Society-operated Homeless Outreach Resource Centre for the past five years. There he acts as the kitchen operator and resident handy-man, arranging food distribution, washing floors, making coffee, transporting supplies, and generally doing what is needed. Jim also volunteers with the K.R.I.B. Youth Centre, providing support with donations of food for young people in need.

**Sonia Purewal:** Sonia has been an active volunteer with St. Michael's Centre long-term care and with the South Burnaby Eagle's Basketball program for over eight years. At St. Michael's Centre Sonia volunteers by giving manicures and visiting room-bound residents. Well beloved by the participants in the basketball program, Sonia contributes her time and talents to all aspects of the Eagle's operations, including serving, over the years, as coach, assistant coach, and scorekeeper.

As Sonia Purewal was not able to attend the award ceremonies, Sonia's sister, Amandeep, accepted the award on her behalf.

**Nellie Wong:** Nellie has been a stalwart volunteer in the Burnaby community for over 20 years. Among her numerous roles, Nellie has volunteered with the Burnaby Association for Community Inclusion for 23 years as a community advocate for persons with disabilities, as an educator, as a member of the Advocacy Committee, and as a supporter of the organization's family-based initiatives. Since 1992 Nellie has also been a member of the Burnaby Access Advisory Committee, which advises the City's Planning and Building Department on access and inclusion issues related to persons with disabilities. As well, Nellie is currently a Board member of the ConnecTra Society, and is a long-time volunteer with the Family Support Institute, both Lower Mainland organizations supporting persons with disabilities.

His Worship, Mayor Derek R. Corrigan, congratulated the Local Hero Award winners for their service to the community and their support in making Burnaby the "best run" city in Canada.

### 5. <u>NEW BUSINESS</u>

Councillor Calendino advised the UBCM, at its convention held last week, expressed concern regarding the lack of progress in RCMP contract negotiations between the federal and provincial governments.

Arising from discussion, Councillor Calendino was granted leave by Council to introduce the following motion:

"WHEREAS the current RCMP contract is due to expire in 2012; and

WHEREAS there has been no progress in the RCMP contract negotiations between the Government of Canada and the provincial governments of six provinces and 3 territories which started several years ago; and

WHEREAS the Government of Canada seems intent at keeping the status quo which is unacceptable to the aforesaid provinces and territories; and

WHEREAS there was much discussion at the UBCM 2011 convention last week indicating serious disappointment and frustration at the federal government wanting to impose a unilateral agreement by the end of November 2011; and

WHEREAS there was a request by the BC negotiating team to have municipalities express their concern and dissatisfaction with the position of the Government of Canada by lobbying the local MPs, the Minister responsible and possibly the Prime Minister:

THEREFORE BE IT RESOLVED that the Mayor of Burnaby write the local MPs (government and opposition), the Minister responsible and the Prime Minister requesting that the Government of Canada, in the spirit of collaboration and partnership, return to the table to negotiate the settlement of a new RCMP contract that addresses the outstanding issues of a new partnership, cost containment and accountability.
