- B) Mr. Lee Loftus, Business Manager, International Association of Heat and Frost Insulators and Allied Workers Union Local 118, and Mr. Andre Pachon, Past President, B.C. Insulation Contractors Association, appeared before Council to present information on the importance of mechanical insulation and inspections. Mr. Loftus introduced Mr. Chris Ishkanian, Manager, Burnaby Insulation and long time Burnaby resident also in attendance at the meeting.

To illustrate the use of insulation the speaker gave the example of hot coffee and cold pop and how we use insulation to keep them hot and cold and applied the same principle to buildings, keeping them warm in the winter and cool in the summer. The delegation included a slide presentation "Mechanical Insulation: the 1% Solution" which highlighted their example of how mechanical insulation would equal just 1% of total project costs. Mr. Loftus advised the pay offs of using mechanical insulation include: significant financial savings (14% per year); supporting jobs of highly skilled workers; preventing fires; reducing noise; and reducing energy consumption, which means less pollution and green house gas emissions. The speaker then outlined some of the costs of doing mechanical insulation the wrong way.

On behalf of the insulators of Local 118, Mr. Loftus requested the inclusion of effective and mandatory mechanical insulation in the City's tendering and procurement processes. The delegation also urged Council to lobby the Provincial Government to make changes to the B.C. Building Code as recommended by their union as well as environmental organizations, architects, engineers and developers. In conclusion, Mr. Loftus asked Council for its support and promotion of these changes in order to save money and the planet.

Arising from the presentation by the delegation, Councillor Jordan was granted leave by Council to introduce the following motion:

All services are to be designed to City standards and constructed in accordance with the Engineering Design.
 - c) The removal of all existing improvements from the site prior to Final Adoption but not prior to Third Reading of the Bylaw. Demolition will

be permitted after Second Reading of the Rezoning Bylaw has been granted provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse or vandalism.

- d) The submission of a conceptual suitable on-site stormwater management system to the approval of the Director Engineering and the granting of a Section 219 Covenant to guarantee its future provision.
- e) The submission of a geotechnical review confirming that the site may be used safely (stability) for the intended use for review by the Chief Building Inspector and granting of a Section 219 Covenant respecting the submitted report.
- f) The granting of any necessary statutory rights-of-way, easements and/or covenants.
- g) The completion of the sale of City Property.
