In Memorium

It is with genuine regret that I must inform Council and the Citizens of Burnaby of the passing of Freeman Eileen Dailly on January 17, 2011.

Freeman Dailly lived a life of dedicated service to the people of Burnaby and the Province of British Columbia. At the tender age of 15, Eileen became a member of the Co-operative Commonwealth Federation (otherwise known as the CCF), igniting her passion for service and quest to improve the lives of those around her.

Following high school, Eileen graduated from Normal School and at the age of 18 began her teaching career in a one room school house on Denman Island. In 1947 she moved to Burnaby and taught until 1955 at Kitchener and Inman Avenue Schools. Having married in 1951, Eileen

decided to stop teaching in 1956 when she began to raise her young family. However this did not prevent her from participating in the community and in 1956 she was elected as School Trustee for the Burnaby School Board. She went on to win re-election for four additional terms, serving as Chair for three of those terms.

In 1966, NDP party members encouraged Eileen to run for provincial office in the newly created constituency of Burnaby North. Not only did she win the seat in 1966, but she went on to be reelected in 1972, 1975, 1979 and 1983. From 1966 until 1972, Eileen served as the NDP's "shadow critic" of education and when the NDP was elected to form the government in 1972 under Premier Dave Barrett, she was appointed as the Minister of Education. Eileen was the second woman to be named Minister of Education and she went on to become the first to serve as Deputy Premier.

Eileen's list of accomplishments while in office is long, but among the highlights are the introduction of mandatory kindergartens in the province, the abolition of corporal punishment in BC schools, and the creation of the first Aboriginal School District. Her contributions were so highly regarded that although the NDP government was defeated in 1975, Eileen won re-election and remained the MLA for Burnaby North until she retired in 1986.

After her retirement, Eileen remained an active participant in community affairs as she went on to host a seniors' program on the local cable television network and served on the executive of the provincial Retired MLAs Association.

In 1987, Eileen was recognized for her life of public service when she became the first woman to receive Burnaby's highest honour; Freeman of the municipality.

Eileen's legacy continues to live on through her many accomplishments while in public office and through the spirit of service that embodied her life.

We extend out deepest condolences to her son Robert, daughter-in-law Sally, her grandchildren and many friends and relatives. She will be truly missed.

The delegation advises the tower will accommodate three antennae, one dish and is capable of supporting three to four additional carriers. An independent visual impact study concludes the impact on area businesses and residents would be minimal. In addition SBA Communications Inc. attests the wireless communication facility complies with Health Canada's Safety Code 6 and meets all CSA, Nav Canada and Transport Canada requirements. The site will be fenced and secure and avoids utilities and nearby parking facilities.

In conclusion the delegation advised they have had ongoing discussions with staff about the proposed tower construction and believe the option as presented is the best possible solution to facilitate tower construction.

 - c. The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d. The submission of an undertaking to remove all existing improvements from the site prior to Final Adoption of the Bylaw, but not prior to Third Reading of the Bylaw. Demolition of any improvements will be permitted after Second Reading of the Rezoning Bylaw has been granted, provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse and vandalism.
 - e. The dedication of any rights-of-way deemed requisite.
 - f. The undergrounding of existing overhead wiring abutting the site.
 - g. The granting of any necessary statutory rights-of-way, easements and/or covenants.
 - h. The granting of a Section 219 Covenant restricting enclosure of balconies.
 - i. Compliance with the Council-adopted sound criteria.
 - i. Compliance with the guidelines for underground parking for visitors.
 - k. The provision of a covered car wash stall and adequately sized and appropriately located garbage handling and recycling material holding space and a commitment to implement the recycling provisions.
 - 1. The pursuance of Storm Water Management Best Practices in line with established guidelines.

- m. The provision of facilities for cyclists in accordance with Section 4.5 of the rezoning report.
- n. Submission of a Site Profile and resolution of any arising requirements.
- o. The deposit of the applicable Parkland Acquisition Charge.
- p. The deposit of the applicable GVS & DD Sewerage Charge.
- q. The deposit of the applicable School Site Acquisition Charge.
- r. The submission of a written undertaking to distribute area plan notification forms, prepared by the City, with disclosure statements; and, to post area plan notification signs, also prepared by the City, on the development site and in the sales office in prominent and visible locations prior to Third Reading, or at the time marketing for the subject development commences, whichever is first, and remain posted for a period of one year, or until such time that all units are sold, whichever is greater.
