A) Mr. Scott Laliberte, President, Burnaby Velodrome Club, 7564 Barnet Highway, Burnaby, appeared before Council to provide an update on the past two years of their operations. The speaker advised club membership continues to increase every year. The club currently offers a youth cycling program, masters training session, coach training opportunities and elite training sessions for world class athletes.

The speaker concluded by noting the marquis event at the cycling facility, the Burnaby 4 Day, was held in December of last year and included Olympic cyclists from Canada, the US and Europe.

B) Mr. Gordon World, 7478 Sandborne Avenue, Burnaby, appeared before Council to provide information regarding laneway housing. The speaker noted this type of housing is currently permitted in Vancouver, North Vancouver and Powell River. Laneway

houses are detached dwellings located in the typical garage area of a single family lot, facing the laneway and maintaining backyard open space. Limited to rental or family use only, with no permitted strata titling, laneway housing is intended to respond to the need for diverse kinds of rental housing in communities. The speaker concluded by encouraging Burnaby to consider permitting laneway housing.

C) Ms. Isabel Kolic and Ms. Josie Romeo, Heights Merchants Association, 4019 Hastings Street, Burnaby, appeared before Council expressing concern regarding certain proposals to address traffic issues in the Burnaby Heights and Capitol Hill Neighbourhood.

The delegation noted the following points:

- the hours of operation for the Hastings Street HOV lanes should not be extended; HOV lanes are not pedestrian friendly; they do not encourage foot traffic in the neighbourhood retail district;
- City owned parking lots near Hastings Street should not be used for employee or staff parking; they should be used only for customer parking;
- proposed left turn lanes on Hasting Street at Gilmore Avenue will result in the loss of street parking on that block.

The speakers acknowledged the excellent working relationship between the Heights Merchant Association, Council and City staff. They concluded by expressing appreciation for the opportunity to express their views regarding these important issues.
