C) Traffic Safety Committee

Re: Crosswalk – Chaffey Avenue at Sardis Street

The Traffic Safety Committee submitted a report in response to pedestrian safety concerns at the intersection of Chaffey Avenue and Sardis Street. A review of the intersection concluded that the installation of a marked crosswalk is not warranted. However, an extension to the existing parking restriction at the south east corner and installation of new parking restrictions on the west side of the intersection is recommended to enhance pedestrian visibility and safety. Due to concerns from adjacent owners, the removal of on-street parking spaces has been limited to one that is fully within the intersection.

The Traffic Safety Committee recommended:

- 1. THAT Council endorse the parking restrictions at the intersection of Chaffey and Sardis as detailed in this report.
