His Worship, Mayor Derek R. Corrigan welcomed 'YMCA Summer Work Student Exchange Program' students from Quebec. The students thanked Mayor and Councillors and noted they are currently working for non-profit organizations and are living in Burnaby during the summer exchange program.

His Worship, Mayor Derek R. Corrigan announced that Christine Sinclair and Curtis Moss, two local, talented, hard-working and nationally celebrated athletes are preparing to compete with the word's best in the London 2012 Olympics from July 27 to August 12.

#### **Christine Sinclair**

• After scoring more than 130 goals for the national team and serving as both its captain and inspirational talisman, Christine Sinclair is widely recognized as one of the top female soccer players in the world.

- Christine was born and raised in Burnaby, and by age 11 was already talented enough to make the province's under-14 girls' all-star team.
- Christine led the Burnaby Girls Soccer Club to five provincial titles and a pair of top-five national finishes.
- As a teenager, she also spurred Burnaby South Secondary School to three league championships.
- After winning the Golden Boot scoring title at the FIFA U-19 Women's World Cup in Edmonton, Christine established herself as a lethal striker for the senior team, for which she's played a record 181 times and counting. She's equally renowned for her drive and passion on the field and unassuming modesty off the field.

#### **Curtis Moss**

- Curtis is set to fulfill a personal dream by competing at London 2012 after winning the Canadian Olympic Trails in Calgary last month and nailing a personal-best throw of 81.21 meters in Victoria.
- Curtis was born in New Westminster and grew up in Burnaby, the son of former BC Lions running back Leroy Moss and Jeanie Moss, a former employee with the City of Burnaby.
- He attended Chaffey-Burke Elementary and later Burnaby Central High School where he was a standout in football and track & field.
- He is a former Canadian National Junior Champion and a two-time Canadian Senior National Champion in javelin.
- He is coached by Burnaby Sport Hall of Fame member Don Steen.
- We'll be cheering extra hard since Curtis has worked for the City of Burnaby as part of our Election Office team and before that filled temporary assignments at the Clerk's Office.

## **Canadian Olympic Rowing Teams Trained at Burnaby Lake**

- On July 5, I had the pleasure to welcome Canadian Olympic Rowing Teams to Burnaby after their training session on Burnaby Lake.
- One women's rowing team and three men's rowing teams spent 3 days on the lake training in preparation for the Games in London.
- The team won 4 medals at the 2008 Beijing Olympics including gold for the Men's Eight.
- After the completion of the rejuvenation project last year, it is exciting to see athletes of this calibre selecting Burnaby Lake as a venue to train.

- **Mr. Norman Bacon**, 6438 McKay Avenue, Burnaby, appeared before Council requesting Council pass a bylaw to prohibit foul language and spitting in public. The speaker suggested a \$50 fine for the noted offences.
- Ms. Kathy Powelson, Executive Director of Paws for Hope Animal Foundation, appeared before Council seeking a ban on sale of puppies, kittens and bunnies in the pet stores in Burnaby. The speaker noted that this is not only an animal welfare issue, but also an issue for tax payers, and a consumer protection issue. The pets being sold in stores are not coming from a responsible or reputable source that has the best interests of the animals in mind.

Ms. Powelson advised that mills are commercial breeding facilities operated with an emphasis based on profit above animal welfare. Animals are forced to live in inhumane conditions; confined in small wire structures for their entire lives, live amongst their filth and waste and when fed, are forced to eat in the same confined areas. Their health issues are not attended to and they often suffer from eye, ear and respiratory infections, behaviour issues, malnutrition, etc.

The speaker shared a story of "Shelby", a dog purchased in 2004 from the Brentwood Mall pet store. Shelby suffers from a number of health issues and to this day, her owner has spent \$32,281.51 on veterinarian bills.

In 2011, over 100 cats and dogs were surrendered to the Burnaby SPCA and the Vancouver Kitten Orphan Rescue Association (VOKRA) rescued approximately 150 feral, free roaming, and abandoned cats and kittens. According to rabbit advocacy and rescue groups, Central Park is a common dumping ground for domestic bunnies. This places a heavy burden on the municipal shelters, which are funded through residents' taxes.

This will result in a lower MRN funding level for Burnaby in 2013 compared to 2012, but still higher than the funding allocated in 2011.
