The 'Open' Council meeting reconvened in the Council Chamber at 7:00 p.m.

IN MEMORIUM

His Worship, Mayor Derek R. Corrigan advised that Cicely Mary Brown passed away on January 24, 2012 at the age of 86. Cece worked tirelessly and cheerfully to develop some of our best attributes and attractions and helped to teach hundreds of schoolchildren – and other Burnaby Village Museum visitors – about our City's rich history. She also made a huge contribution to the restoration of two of Burnaby's greatest attractions – the 1912 C.W. Parker Carousel and the Interurban 1223.

To acknowledge her exemplary service, Cece was given some of our city's highest honours including the Kushiro Cup as our Outstanding Citizen of the Year in 2003. On behalf of Burnaby City Council and the Citizens of Burnaby, His Worship, Mayor Derek R. Corrigan expressed sincere condolences to Cece's family and friends.

Mr. Tony Drescher, General Manager, Cliff Avenue Synergy U-18 Girls Soccer Team, and **Ms. Simran Parmar**, **Ms. Marina Sulmona** and **Ms. Samantha Drescher**, three players on the team, appeared before Council to thank the City for its generous contribution to team travel expenses to the 2008 and 2011 National Championships. The

team won the National title in 2008. As a token of their appreciation, the delegation presented His Worship, Mayor Derek R. Corrigan with a framed photograph of the team.

B) Mr. Gary Murphy, Chief Project Officer, Smart Metering Program, BC Hydro, appeared before Council to provide an overview of the program. BC Hydro is in the midst of updating and upgrading the province's electricity system and smart meters are an important part of this process. The delegation advised the new meters will help BC Hydro get the lights back on faster and more safely in the event of an outage. Mr. Murphy also stated meters provide people with tools to manage their energy use and save money, reduce electricity theft and help keep hydro rates low by reducing waste.

The delegation advised that smart meters do not pose a health risk noting their power signal is less than $1/10^{th}$ of a cell phone. In fact, the radio frequency from a smart meter over its entire 20 year life span is equivalent to the exposure during a single 30 minute cell phone call.

The delegation concluded by noting the smart meter program has not changed anything regarding obligations under the Freedom of Information and Protection of Privacy Act. No private customer information is stored on a smart meter. BC Hydro is only concerned about aggregate usage patterns, not those of individuals.

Councillor Chang retired from the 'Open' Council meeting at 7:59 p.m.

In response to a query from Council, Mr. Murphy confirmed time of use rates are not part of the smart meter program.

Councillor Chang returned to the 'Open' Council meeting at 8:06 p.m. and took his place at the Council table.

Arising from the presentation by the delegation, Council requested copies of the business case for smart meters and the report prepared by Darryl Plecas regarding electrical consumption by indoor grow operations.

C) Mr. Stephen Rowe, 9475 Snowberry Court, Burnaby, appeared before Council regarding a potential use for the 65 acres of land just off Kensington Avenue where the soil dredged from Burnaby Lake was deposited. Mr. Rowe described this location as the ideal place for a man-made swimmable lake and amphitheatre. The speaker noted this site could also include such features as a water park, lap pool, water volleyball courts, workout stations and walking trails. The speaker concluded by providing Council with a schematic of his proposal.

Councillor Calendino retired from the 'Open' Council meeting at 8:25 p.m.

A) Environment Committee

Re: 2012 Environment Week and Environmental Awards Program

The Environment Committee submitted a report seeking Council approval for the preliminary planning approach for Environment Week and the Environment Awards Program call for nominations for 2012. Environment Week, together with the Environmental Awards Program, celebrates Burnaby's ongoing commitment to environmental sustainability through the coordination and promotion of environmental events and activities. The intention of this year's proposed theme, 'Water – Ours to Conserve and Protect', will be to encourage public awareness of our healthy watersheds, water conservation and the essential function that water and public water systems perform in the City.

The Environment Committee recommended:

1. THAT Council approve the preliminary planning approach of Environment Week, scheduled for 2012 June 3 to June 9.

- 2. THAT Council approve the call for nominations for the 2012 Environmental Awards Program.
- 3. THAT Council approve an expenditure of \$4,350 from the Boards, Committees and Commissions' operating budget for advertising the Environmental Awards Program call for nominations.
- 4. THAT Council approve an expenditure of \$5,650 from the Boards, Committees and Commissions' operating budget for advertising the Garage Sale Day Event.

1. Burnaby Farmers' Market – Relocation to City Hall

The City Manager submitted a report from the Director Planning and Building seeking Council approval of the relocation of the Burnaby's Farmers' Market to the Burnaby City Hall - North Parking Lot from the Burnaby Village Museum. The society operating the market has determined that the City Hall location provides vendors and customers with better access, more parking and allows more opportunities for expansion and growth.

The City Manager recommended:

1. THAT Council support the relocation of the Burnaby's Farmers' Market to the Burnaby City Hall – North Parking Lot as outlined in this report.

2. 2011 Population and Dwelling Counts for Burnaby

The City Manager submitted a report from the Director Planning and Building advising Council of the new population and dwelling counts for Burnaby as reported by Statistics Canada in the first release of information from the 2011 Census. Burnaby's population increased by 20,419 people (10.1% over 5 years) from a 2006 total population of 202,799 to a 2011 population of 223,218. The number of residential units increased by 8,433 units (10.1% over 5 years) from 82,950 units in 2006 to 91,383 units in 2011.

The City Manager recommended:

1. THAT this report be received for the information of Council.
