THEREFORE BE IT RESOLVED that the City of Burnaby support the Real Estate Board of Greater Vancouver in their call to urge the Provincial Government to move up the HST to GST/PST transition date from March 31, 2013 to an earlier date in this year;

AND BE IT FURTHER RESOLVED that the City of Burnaby submit this resolution to the LMLGA and UBCM to seek their support for this resolution.
