The 'Open' Council meeting reconvened in the Council Chamber at 7:03 p.m.

His Worship, Mayor Derek R. Corrigan congratulated Christine Sinclair and Curtis Moss, two Burnaby citizens, for their achievements at the Olympic Games in London. The following is the text of the Mayor's remarks:

"Tonight I'd like to touch on a topic that – with good reason – everyone is talking about: The Olympic performance of Burnaby's Christine Sinclair.

As we all know – and, as the world knows –Christine recently did Burnaby proud on the global stage of the 2012 London Olympics. Here in Burnaby, Christine has been making us proud for years, as an exceptional soccer player, an inspirational teammate, and a matchless ambassador for her sport and for our city.

Christine was born in Burnaby. She grew up playing soccer with the Burnaby Girls Soccer Club, helping them to achieve six league titles, five provincial titles and two top-five national finishes.

She also helped her Burnaby South high school team to achieve three league championships and she played for the South Burnaby Metro Club. Of course, after her Burnaby career, Christine went on to the national soccer stage, playing for Canada's under-18 national team, then debuting at the senior level in the 2000 Algarve Cup, in which she led the team in goal scoring with three goals.

After that, Christine began a remarkable soccer career on Collegiate, Club and International soccer teams, throughout her career receiving honours that recognize her unique talent. I could spend the whole council meeting listing Christine's achievements and the awards she has received. To name just a few – in addition to being named to Burnaby's Sports Hall of Fame! – she was MVP of the final, when her Western New York Flash team won the 2011 Women's Professional Soccer championship; she received golden boot, golden ball and player of the year awards in her international career; and she was awarded – this month – the Queen Elizabeth II Diamond Jubilee medal.

His Excellency Right Honourable David Johnston noted that "The recipients who are honoured by this medal have made Canada better. Individually, they have improved the well-being of many in our communities. Together, they have helped to create a smarter, more caring nation. They represent a mosaic of individual experiences and accomplishments. Like Her Majesty, they inspire others to take up the call to service." This certainly describes Christine.

Finally, as we all know, Christine brought Olympic Bronze home from London!

We are all so proud of her – for what she has achieved and, even more importantly, for how she has achieved it. Her determination and humility inspire us all.

Since the Olympics, many of us in Burnaby have been thinking of how best to honour Christine in our city. Citizens have been contacting us with suggestions, which we would like to continue to receive."

Mayor Corrigan proceeded to congratulate Curtis Moss for his achievements at the Olympic Games in London. The following is the text of the Mayor's remarks.

"And while we're talking about the Olympics, I also want to congratulate Curtis Moss, a Burnaby resident (and former City of Burnaby employee!) and a Chaffey-Burke Elementary and Burnaby Central High School alumnus, who participated in the Olympics in Javelin throw. Curtis didn't win an Olympic medal, but he is an exceptional athlete, as evidenced his national titles and his qualification for the Olympic Games. London 2012 was his first Olympics and a huge milestone in his remarkable young career, which has seen him named Canadian National Junior Champion and two-time Canadian Senior National Champion. Here in Burnaby, we're very proud of Curtis' achievements to date and we know his athletic future will be bright.

Again, congratulations to Christine and Curtis – and to all of our Canadian heroes – for their exceptional performances at the London 2012 Olympics."

Staked Townhouse Development
Metrotown Development Plan, Sub-Area 11
3716, 3722, 3730, 3740 and 3748 Thurston Street

The City Manager submitted a report from the Director Planning & Building seeking Council authorization to forward this application to a Public Hearing on 2012 September 18. The purpose of the proposed zoning bylaw amendment is to permit the construction of a three-storey 57 unit stacked townhouse development with full underground parking.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2012 August 27, and to a Public Hearing on 2012 September 18 at 7:00 p.m.

- c. The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
- d. The removal of all existing improvements from the site prior to Final Adoption of the Bylaw. Demolition of any improvements will be permitted after Second Reading of the Rezoning Bylaw has been granted, provided that the applicant acknowledges that such permission does not fetter Council's ability to grant or not to grant Third Reading and/or Final Adoption of the Rezoning Bylaw. In addition, the demolition of any improvements will be permitted at any time if they are vacant and considered by staff to be subject to misuse and vandalism.
- e. The utilization of an amenity bonus through the deposit of funds equal to the estimated value of the density bonus in accordance with Section 3.2 of this report.
- f. The dedication of any rights-of-way deemed requisite.
- g. The consolidation of the net project site into one legal parcel.
- h. The undergrounding of existing overhead wiring abutting the site.
- i. The granting of any necessary statutory rights-of-way, easements and/or covenants including a statutory right-of-way providing public pedestrian access over the proposed public open space area portion of the subject development site.
- j. The granting of Section 219 Covenants including:
 - restricting enclosure of balconies;
 - providing that all disabled parking is to remain as common property;
 - provision, operation and continuing operation of stormwater management facilities; and
 - provision, operation and continuing maintenance of the public open space area, both on-site and within the unopened Thurston Street right-of-way, as identified on the development plans.
- k. In light of the proximity to SkyTrain and Boundary Road, a noise study is required to ensure compliance with the Council-adopted sound criteria.

1. Compliance with the guidelines for underground and surface parking for visitors.

- m. The provision of one covered car wash stall and adequately sized and appropriately located garbage handling and recycling material holding space and a commitment to implement the recycling provisions.
- n. The review of a detailed Sediment Control System by the Director Engineering.
- o. The submission of a suitable on-site stormwater management system to the approval of the Director Engineering, and the granting of a Section 219 Covenant and deposit of sufficient monies to guarantee its provision and continuing operation.

The report noted the City of Burnaby is fiscally responsible and strives to provide outstanding service to its citizens and community with limited monetary resources. In Burnaby the business community is a very important and active contributor to the success of the City, and a valued member of the community.

The CFIB recommendation to cap the business to residential tax rate at a ratio of 2:1 would increase the burden on the average Burnaby residential property owner by over 34%. It is neither feasible or equitable for the City to implement this recommendation.

The City Manager recommended:

The work of this contract involves the construction of curbs, sidewalks and road improvements including minor drainage and electrical work on various intersections in the City of Burnaby.

C.O.B. as Columbia Bitulithic for the Burnaby Heights and Capitol Hill Traffic Calming for a total cost of \$467,766.88 including HST in the amount of \$50,117.88. Final payment will be based on actual quantities and unit prices tendered.

Other submissions failed to meet the technical specifications in key areas including body type, location of sewer cleaning equipment (operator safety concern) and the vehicle turning radius which is critical in cul-de-sacs and laneways. The subject vehicle will replace an existing 2002 model year vehicle, which will be sold at auction on receipt of the replacement unit.

The proposed unit will complement the existing Elgin sweepers in the fleet that have a proven track

record for performance and reliability. The subject vehicle will replace a 2003 unit which will be sold at auction on receipt of the replacement unit.
