SUBJECT:

2013 COUNCIL MEETING, COMMITTEE MEETING

AND PUBLIC HEARING SCHEDULES

PURPOSE:

To set the Council meetings, Committee meetings and Public Hearing schedules

for 2013 and to amend Terms of Reference to reflect the meeting schedules set

out in this report.

RECOMMENDATIONS:

- 1. THAT Council approve the Council meeting, Committee meeting and Public Hearing schedules for 2013 as set out in Appendix "A" "B" and "C" of this report.
- **2. THAT** Terms of Reference for the Community Policing Committee be amended to reflect a bi-monthly meeting schedule as set out in Appendix "C" of this report.
- 3. THAT Terms of Reference for the Audit Committee be amended to indicate that meetings will be held as required (at the Call of the Chair).

REPORT

The Community Charter requires Council to adopt a schedule and give public notice of Council meetings, Committee meetings and Public Hearings in each year. This report fulfills that requirement. It is recognized that adopting this report does not preclude Council from adopting future resolutions to add, cancel or change meeting dates as the year progresses.

1. Council Meetings

Closed Council meetings from which the public is excluded will continue to be held at 6:30 p.m. in the Council Committee Room. During the process of scheduling both Open and Closed Council meetings, consideration has been given to avoid conflict with the FCM and UBCM annual conferences.

2. Public Hearings

Public Hearings proposed in this report for 2013 February, April, June, September, and November will deal with the most recent group of rezoning applications forwarded for consideration under the usual bi-monthly reporting schedule. The Public Hearing dates in January, March, May, July, October and December would be available for other cases such as those rezoning applications previously being processed, and if it is found unnecessary to hold a Public Hearing in these months, the scheduled hearing may be cancelled.

Council has, in the past, approved consideration of special Public Hearings for specific rezoning requests which have not corresponded to the scheduled dates. Unless otherwise directed, the Planning and Building Department will pursue consideration of similar extraordinary cases which may occur in the coming year, as required.

3. Board, Committee and Commission Meetings

As Council is aware, the following Committees meet as required (at the Call of the Chair) and are therefore not included in the attached meeting schedule (Appendix "C"):

- Simon Fraser Liaison Committee
- International Relations & Friendship Cities Committee
- Mayor's Task Force on Graffiti

Staff has been informed that the Community Policing Committee wishes to amend its meeting schedule to a bi-monthly schedule and the Audit Committee is requesting to meet as required rather than scheduled quarterly meetings. With Council's approval, the terms of reference for both Committees will be amended to reflect the new meeting schedules.
