ROAD CLOSURE - 9LIVES ADVENTURE

PURPOSE:

To seek Council approval for a road closure for the "9Lives Adventure Event"

RECOMMENDATIONS:

1. THAT Council approve the road closure as discussed in this report.

2. THAT the coordinator of the event, Karim Ladki, owner of 9Lives Adventure, 569 Silverdale Pl, North Vancouver, BC V7N 2Z6, be sent a copy of this report.

REPORT

A request to use Jubilee Ave between Nelson and Imperial on Saturday June 16th or Sunday June 17th (as the rain date) for the 9Lives Adventure Event being held in Bonsor Park (skateboard area) and the youth centre on Jubilee has been received from Karim Ladki, coordinator of the event. Council approval is required by the Street & Traffic Bylaw.

9Lives Adventure is a company that is introducing more extreme adaptive sports in BC. This event will be the Canadian stop of the 6-part Adaptive Skate Competition Series that features adaptive skateboarding and wheelchair skating. The event runs from 11:00 am to 4:00 pm requiring the closure of Jubilee Ave between Nelson and Imperial (see *attached* map) between 8:00 am to 6:00 pm to facilitate set up and take down. Jubilee Ave will be used for accessible parking, staging of event vehicles, event vendors and sponsors, and pedestrian access between the park and the youth centre.

The event organizers will be required to arrange for barricades and barricade volunteers for the road closure and will be providing a notification letter to affected businesses one week prior to the event.

The organizers are aware that approval is subject to the following conditions:

- 1. That the road closure be conducted under the supervision of one person as organizer.
- 2. That all participants be instructed to respect the rights and property of the individuals encountered en route.

3. That the road closure be covered with liability insurance in the minimum amount of \$5 million with the City of Burnaby named as co-insured, and that the insurance policy include a 30 day cancellation notice and a cross liability clause.

4. That a signed copy of the "City of Burnaby Permit For Short Term Use and Occupancy Of City Lands" be received no later than one week prior to the event.


