The regional food system design and implementation plan will provide a comprehensive vision and basis for a regionally based food system as well as a roadmap of actions that can be taken by various stakeholders including local governments to create a regionally based food system that reflects aspirations for increased food security and self-reliance, greater economic vitality and ecological integrity.

The delegation requested a commitment from the City of Burnaby to engage in the design of and implementation planning for the southwest BC Food System. The delegation also requested a financial contribution to the project of \$4,000 a year for three years and identification of a city staff person to act as liaison to the project team.
