A) Pany Aghili, Executive Director, Dixon Transition Society, appeared before Council to provide an overview of the services and programs provided by the Society. Ms. Aghili noted her organization works to reduce the impact of violence against women and children by providing a safe haven through their transition house, second stage and third stage housing. The delegation noted the City of Burnaby leases land to the Society for the transition house. In addition, the City provided financial support at the time of construction of their second stage housing.

The speaker concluded by advising that further support, including counselling and outreach, complete the Society's continuum of services to empower families to take the opportunity to lead safe, healthy and productive lives.

Brian Daniel, Vice-President, and **Irene McCutcheon**, Advisory Committee Chair, Burnaby Arts Council, appeared before Council seeking support for a new art gallery in the community. The delegation provided a brief history of art gallery proposals and inquired if a new feasibility study would be appropriate.

The delegation noted the Burnaby Arts Council has been advocating for a new first class art gallery at Civic Square for the last two years. The speakers noted consideration should be given to using density bonus funds to build such a facility. The speakers also noted a new art gallery would attract more patrons and this would help to offset operating costs. The delegation concluded by emphasizing the economic and social benefits a new art gallery would bring to the City.

- C) Gordon Smith, 3786 Arbor Street, Burnaby appeared before Council expressing concern regarding construction of mausoleums at Ocean View cemetery. The speaker noted the following points and questions:
 - o The notification area for Board of Variance applications for commercial developments including construction of mausoleums should be expanded beyond 30 meters from the proposed development.
 - Does Ocean View cemetery plan to remove the large hill of dirt on their proposed construction site?
 - o How many more mausoleums will be constructed at the cemetery?
 - O Dust migration measures and enforcement of the noise bylaw are necessary during construction work at the cemetery

The delegation concluded by requesting Council direct all City departments to cease and desist from entering into any further discussions with Ocean View cemetery, its parent

company, its contractor and all their staff until a full public hearing is held to consider the complete construction plan for Ocean View cemetery.

Given the immediate success of the first injection, the Committee recommended all of the knotweed sites in the current management program be converted to the stem injection program to expedite the management of this highly aggressive plant.

These improvements will be achieved in the short term, with further enhancement to the integration of transit service with the Town Centre as the future phases of the proposed Brentwood Mall re-development proceed.

1. <u>Inter-Municipal Business Licence Pilot Program</u>

The City Manager submitted a report from the Director Finance seeking Council approval to establish an inter-Municipal Business Licence Pilot Program with the cities of Delta, New Westminster, Richmond, Surrey, and Vancouver. The main benefit of an IMBL program is the promotion of a business friendly environment and economic development by reducing costs and administration for businesses. Improved compliance with business licence requirements and a modest revenue increase are additional expected benefits for the City of Burnaby.

1. THAT Council adopt a bylaw to establish an Inter-Municipal Business Licence agreement.

2. THAT Council authorize staff to enter into an agreement with the cities of Delta, New Westminster, Richmond, Surrey, and Vancouver to participate in an Inter-Municipal Business Licence pilot program as detailed in this report.

3. THAT Council adopt a bylaw to ratify the Inter-Municipal Business Licence Agreement referred to in Recommendation 2.
