**SUBJECT:** 

WATERWORKS UTILITY RATES FOR 2014

**PURPOSE:** To obtain Council approval for 2014 water rates.

#### **RECOMMENDATION:**

THAT the Finance and Civic Development Committee recommend Council amend the Burnaby Waterworks Regulation Bylaw to provide for the water rates contained in Schedule C, effective 2014 January 01 as outlined in this report.

#### REPORT

#### 1.0 INTRODUCTION

The Waterworks Utility Report provides information and recommendations for funding of the Waterworks Utility through the adoption of an amendment to the Burnaby Waterworks Regulation Bylaw.

The Waterworks Utility Fund is financially self-sustaining and as such does not impact the tax draw. Rates are based on a user pay principle and are structured to fund the entire cost of the delivery and management of Burnaby's water services. Water rates are reviewed annually and revised to account for changes in the cost of water and costs associated with delivery of the service. Schedule A provides the City's Waterworks 5-Year Operating Budget.

Utility fees are collected separately from property taxes and are due by March 15 each year. To promote payment by the due date, Burnaby offers a 5% discount for payments received on or before March 15 of a given year. Metered water users are offered the same 5% discount for payments made within 30 days of the billing date on the metered water bill.

#### **2.0 2014 RATE SETTING**

The rate structure is set to include the funding of the City's capital infrastructure renewal programs. The projected 2014 rate increase of 5.5% reflects an increase in the supply cost of water provided by the Greater Vancouver Water District (GVWD), and the continued funding of infrastructure replacement and maintenance programs.

The annual contribution to capital provides funding for the capital water works program shown in Table 1.

The GVWD provides a reliable source of safe, high-quality drinking water to Burnaby and is responsible for acquiring and maintaining the water supply, treating it to ensure its quality and delivering it to the City. Burnaby pays the GVWD for the delivery of water on the basis of volume (cubic metres used). The 2014 estimated cost of water is \$25,993,600.

The GVWD supplies water to Burnaby at peak rate (effective June to September) and non-peak rates. For 2014, the blended rate is 62.01 cents per cubic meter, an increase from 59.63 cents per cubic metre. The GVWD cost of water accounts for approximately 54% of the City's 2014 Waterworks Operating Budget. The Waterworks Operating Budget provides for ongoing work by the GVWD for water treatment and other improvements, including upgrading of facilities to meet safety and environmental standards. Schedule B summarizes the projected increase in the cost of water to Burnaby for 2014 based on GVWD rates and estimated consumption.

The increase in water utility fees for 2014 is required to safeguard against future large supply cost increases and to provide a stable means of funding the City's ongoing capital infrastructure program. Table 2 provides the City of Burnaby Waterworks rate changes since 2009:

### 2.1 Flat Rate Change

The proposed rates will increase the utility bill for a single family home by \$28.40 to \$544.87 if payment is made on or before the due date of 2014 March 15. The charge for a single family home after the due date of 2014 March 15 will increase by the 5% discount to \$573.55. Schedule C provides the proposed Waterworks Rates for 2014.

### 3.0 REVISIONS TO THE RATES SCHEDULE

In addition to the general rate increase, a number of adjustments have been made to bring fees in line with current Engineering practices and to accommodate program changes. Comparative information was gathered from six neighbouring municipalities. Although fees varied among municipalities in general the City of Burnaby was either lower than the highest neighbouring rate, or comparative rates were not available. In future these fees will be reviewed annually to ensure adequate recovery of service costs. Table 3 sets out the new rates.

#### 4.0 RECOMMENDATION

It is recommended that Council amend the Burnaby Waterworks Regulation Bylaw to provide for the water rates contained in Schedule C, effective 2014 January 01 as outlined in this report. The proposed rate adjustments will ensure that the Water Utility continues to be financially self-sustaining. Once approved by Council, a general notice informing users of the rate increase will be placed in a local newspaper and *InfoBurnaby*. Metered users will be notified by letter.

The Director Engineering concurs with the recommendations contained in this report.
