A) Anne Waller, Administrator, Citizen Support Services, accompanied by Sieu Lan Wong, a dedicated volunteer, appeared before Council to present the 2012 Annual Report.

Ms. Waller presented a video regarding the programs provided by Citizen Support Services to both young and old clients. The video featured Kay Charter, a 101 year old

Burnaby resident, who participates in Gadabouts bus trips and the luncheon program. In addition, the video showed a young family benefitting from the Cuddle Program.

Ms. Sieu Lan Wong, a 25 year volunteer, noted helping others is enjoyable and rewarding and she encouraged citizens to volunteer with the Cuddle Program, Gadabouts bus trips and other valuable programs offered by Citizen Support Services.

B) Miriam Larson, Coordinator, and **Hans Olsen**, Chairperson, Voice of Burnaby Seniors (VOBS) appeared before Council describing their activities and programs to support Burnaby Seniors in being healthy, independent and connected community members.

Ongoing projects include the South Burnaby Neighbourhood House Senior Ambassador Program, transit field trips and community resource cards. VOBS members are also involved with the Burnaby Fall Prevention Society's Safe for Seniors, Safe for All Project. In addition, VOBS looks forward to participating in the accessibility audit being planned for the Cascade Heights neighbourhood.

Mr. Olsen concluded by congratulating the City of Burnaby for being recognized as an age-friendly community and thanking Council and staff for providing excellent support to their organization.

C) Carla Zanotto, 9860 Seacote Road, Richmond appeared before Council to discuss zoning issues for 8186 13th Avenue. Ms. Zanotto advised that she would like to subdivide the subject property through spot rezoning instead of the area rezoning process. In support of her request, Ms. Zanotto submitted a map noting three of the four other lots on her side of the block are already duplex lots. The speaker also noted fourteen of the sixteen lots across the lane on 12th Avenue are 32 or 33 foot lots.

The Audit Committee submitted a report presenting Council with the 2012 Financial Statements. The report emphasized the City's ability to meet its current commitments and finance its future liabilities as reflected in the City's Net Financial Assets.

B) The City Manager presented a report dated 2013 April 22 on the matters listed following as Items 01 to 07 either providing the information shown or recommending the courses of action indicated for the reasons given:

1. Film and Television Industry in Burnaby

The City Manager submitted a report from the Director Planning and Building providing Council with information on the contribution and benefits of the film and television industry to the community of Burnaby. Burnaby is a choice location for film and television production in British Columbia and benefits from an estimated minimum annual injection from that industry into the local economy of at least \$408 million. However, the BC industry has lost ground to Ontario in recent years and has slipped to fourth place, behind Los Angeles, New York and Ontario, as a North American production centre. Although Burnaby boasts 62% of purpose-built film studio space in the Lower Mainland, much of that studio space was significantly under-used in 2012 and the first quarter of 2013. As such, the report emphasized the importance of taking action to reverse the declining fortunes of the BC film and television industry.

The City Manager recommended:

- 1. THAT the Mayor, on behalf of Council, write to the leaders of the political parties campaigning to form the next provincial government informing them of the value of the film and television industry to Burnaby, and of Council's desire that carefully reasoned and timely steps be taken to maintain British Columbia as an attractive location for film and television production.
- 2. THAT copies of this report be sent to the Motion Picture Production Industry Association, Burnaby Board of Trade and Tourism Burnaby.
- 3. THAT a copy of this report be sent to all candidates in the upcoming Provincial election within Burnaby to call attention to the importance of the film and television industry to the community of Burnaby.
- 4. THAT a copy of this report be sent to the Lower Mainland Municipal Association as a means of highlighting the importance of the film and television industry to the Lower Mainland region.

2. Local Government Awareness Week 2013

The proposed 2013 theme of 'Support Burnaby Business' would focus on increasing public awareness of the role(s) the City plays in promoting economic development and in promoting to the public the benefits that accrue to the local community through support for Burnaby-based businesses. Proposed activities to recognize LGAW 2013 include a City proclamation, website and social media features, newspaper highlights and a Board of Trade Display at City Hall.

The City Manager recommended:

- 1. THAT Council approve the City's involvement in Local Government Awareness Week 2013, as outlined in Section 2.3 of this report.
- 2. THAT a copy of the report be forwarded to the Burnaby Board of Trade at 201 4555 Kingsway, Burnaby, BC V5H 4T8, for information.

3. 2013/2014 Facility Use, Program and Services Fee Schedule

recommended to increase by 2.5% based on inflationary projections and additional costs of providing services at fair and competitive pricing.

- 2. THAT the Burnaby Recreation Fees and Admissions Bylaw 2013, Burnaby Shadbolt Centre and Burnaby Art Gallery Rental Fee Bylaw 2013, and Burnaby Village Museum Fees Bylaw 2013 be brought down as detailed in Attachment "A", circulated under separate cover.

6. 4748 Brentlawn Drive Proposed Change to Regional Sanitary Sewerage Area Boundary

The City Manager submitted a report from the Acting Director Engineering seeking Council approval to propose an adjustment to the current regional sewerage area boundary for the lots on the south side of the 4700 block of Brentlawn Drive. Staff have received a request from the homeowner of 4748 Brentlawn Drive proposing to extend the existing sanitary sewer in the lane south of the property in order to facilitate a gravity sanitary sewer connection and eliminate the need for a sanitary sump pump. Staff have reviewed the proposal and concur that the request is supportable, staff have also confirmed the feasibility of extending the lane sewer to the end of the block in order to allow all lots on the south side of Brentlawn to utilize a gravity sanitary sewer connection upon redevelopment.

The City Manager recommended:

1. THAT Council approve the proposed change in sanitary sewer service strategy for the lots on the south side of the 4700 block of Brentlawn Drive.
