MOVED BY COUNCILLOR McDONELL: SECONDED BY COUNCILLOR KANG:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

A) **Mr. Jorge Santa Barbara,** 3842 Myrtle Street, Burnaby, a behaviourist and professional dog trainer, appeared before Council to address issues regarding breed specific legislation.

The speaker presented a video noting the importance of teaching a dog how not to react to provocation from other dogs. The speaker also noted if you take the most sociable dog and muzzle and leash it, then that dog will become less social, more reactive, and more dangerous.

The speaker noted the following suggestions:

- alter breed specific legislation to behaviour specific legislation;
- create dog training programs which focus on prevention; and
- use money generated from fines to pay for dog training programs.

The speaker concluded by requesting Council direct City staff to work with him and other professionals to develop potential amendments to specific sections of the Animal Control Bylaw.

B) Anna MacNeil – Allock, 8558 Redrooffs Road, Halfmoon Bay, B.C. and Rebeka Breder, an animal law lawyer, appeared before Council to address proposed amendments to the Animal Control Bylaw.

Ms. Breder referenced the animal control report prepared by City staff and noted her support for the guiding principles in the report as well as establishment of a list of prohibited animals and the proposal to increase the number of dogs permitted per household from two to three. The speaker, however, also expressed several concerns and noted the following points:

- judges in dangerous dog cases do not consider breed to be a relevant factor; their focus is on public safety and responsible pet ownership;
- the proposed city bylaw amendments should focus on known risk factors such as the sexual status of the dog, any underlying disease of the dog, and victim behaviour; and
- the City staff report is based on flawed and inaccurate analysis; in her opinion, the data from the website <u>www.dogsbite.org</u> is not objective.

Ms. Breder asked Council not to pass breed specific legislation and instead continue to carefully review the research and data with stakeholders and reliable sources.

Ms. Anna MacNeil-Allock noted the following points:

- breed specific legislation does not decrease dog bites according to a UBC Canadian Animal Control study;
- Burnaby does not have a dog problem. Burnaby has the fourth lowest bite rate in Western Canada at 1.7 bites per 10,000 population;
- from 2006 to 2011 Burnaby's population increased by 10% and the bite rate increased by 9%;
- 2006 to 2011 dog bites statistics indicated the following:
 - Pitbulls represent 2% of licensed population and are involved in 3% overall bites and 6% of recognized bites;
 - Shepherds represent 5.4% of licensed population and are involved in 7% of overall bites and 12% of recognized bites;
- in 2008 a study found Pitbulls to be lower in aggression to owners and strangers compared to other breeds;

- in Germany, 415 Pitbulls were no different from Golden Retrievers in a behaviour test for aggression;
- 2011 UBC study indicated the following:
 - Pitbulls are less aggressive towards their owners;
 - Pitbull adopters are responsible and diligent; they consider their dogs as family members;
- decrease dog bites through very active ticketing and education.

The delegation asked Council not to proceed with the proposed changes to the Animal Control Bylaw. The speaker also urged Council to send the proposal back for another review that considers relevant research.

C) **April Fahr,** 346 Alberta Street, New Westminster and **Jessica Rumm,** 105 Madison Avenue North, Burnaby, appeared before Council to discuss the realities, repercussions and hidden costs of breed specific legislation.

The delegation compared Breed Specific Legislation to Dangerous Dog Legislation and noted the following points:

Breed Specific Legislation:

- never shown to reduce dog bites
- not supported by major organizations
- expensive
- animal control officers are policing breed, not behaviour
- an increase in licence fees means Pitbull owners are less likely to identify their dogs
- an increase in the impound period means surrender rates increase, low adoptability for Pitbull breeds, deterioration of the animal and a rise in kennelling costs and euthanasia rates

Dangerous Dog Legislation

- proven to reduce dog bites
- endorsed by every credible animal, legal and public health organization
- targets known risk factors for canine aggression and owner responsibility
- fines and tickets bad owners until they become more responsible
- provides broader tool kit for animal control officers and includes multitiered definitions of aggressive, vicious, and dangerous dogs

The delegation concluded by requesting Council vote against the current recommendations, further review Breed Specific Legislation and draw upon best practices and research available from the SPCA and neighbouring communities.

6. 2012 Roadworks and Streetlighting LASP

The City Manager submitted a report from the Director Engineering seeking Council approval of the revised expenditure for engineering services related to the 2012 Roadworks and Streetlighting Local Area Services Program. During the course of the project the consultant required additional effort due to a longer than anticipated construction schedule. The total project cost is within the project budget previously approved by Council; however, the final projected contract administration cost of \$265,000 exceeds the approved Engineering Agreement budget of \$248,000.

The City Manager recommended:

THAT Council approve the revised amount of \$265,000 (inclusive of taxes) under the existing Engineering Agreement E25/2011 with Vector Engineering Services Ltd. for engineering design and contract administration services related to the 2012 Roadworks and Streetlighting Local Area Services Program.
