### **PRESENTATION**

'City of Excellence Gold Standard Award'

<u>Presenters:</u> Dave Baspaly, Executive Director, BC Common Ground Alliance
Cathy Cook, Executive Director, BC Municipal Safety Association

Cathy Cook, Executive Director, BC Municipal Safety Association and Dave Baspaly, Executive Director, BC Common Ground Alliance advised that the City of Burnaby has been awarded the 2012 City of Excellence Gold Standard Award. This award recognizes local governments who have outstanding safety practices related to ground disturbance. Ms. Cook noted the City

engaged in over 2000 excavation projects in 2013 and achieved a 70% reduction in excavation related incidents compared to 2011.

The delegation commended the City for its ongoing commitment to provide a safe working environment and presented the 2012 City of Excellence Gold Standard Award to His Worship, Mayor Derek Corrigan who was accompanied by Deputy City Manager Lambert Chu, Acting Director Engineering Barry Davis and Director Parks, Recreation and Cultural Services Dave Ellenwood.

# 3. Rezoning Reference #13-15 Proposed Addition to a Heritage Home X. Reference Rezoning #04-15

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2013 July 23. The purpose of the proposed zoning bylaw amendment is to permit the construction of a 92.81 m<sup>2</sup> (999 ft<sup>2</sup>) addition to the rear of the Cunningham House, a single family residence that is designated as a City heritage building. The property is located in the R3a Residential District, and is subject to a Section 219 covenant restricting development to that shown on the approved development plans. Amendment of the Section 219 covenant requires approval through the rezoning process.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2013 July 8 and to a Public Hearing on 2013 July 23 at 7:00 p.m.
- 2. THAT the following be established as prerequisites to the completion of the rezoning:
  - a) The submission of a suitable plan of development.
  - b) The amendment of the existing Section 219 covenant requiring the land to be developed in accordance with the approved building and landscape plans.
  - c) The approval of the required Heritage Alteration Permit.

# 5. Willingdon Pump Station Proposed Change to Pump Station Service Area And Regional Sanitary Sewerage Area Boundary

The City Manager submitted a report from the Acting Director Engineering seeking Council approval for a proposed amendment to Regional Sewer area boundaries. Staff have identified an opportunity to implement a strategic diversion of a portion of the Willingdon Pump Station catchment to the Beta Pump Station. This proposed diversion would eliminate the requirement to upgrade the Willingdon Pump Station for capacity purposes, as well as related sewer infrastructure. The Willingdon Pump Station catchment area is contained within the Vancouver Sewerage Area while the Beta Pump Station catchment area is contained within the Fraser Sewer Area. This diversion of the catchment will require an amendment to the regional boundary and, consequently, approval from Metro Vancouver is required.

The City Manager recommended:

1. THAT Council approve the proposed amendment of the Regional Sewer area boundaries as detailed in this report.

(c.o.b as Columbia Bitulithic for a total cost of \$1,936,803.75 including GST in the amount of \$92,228.75 for work as outlined in this report. The work of this contract involves the construction of approximately 900 m of new dyke along the shore of the Fraser River North Arm between Boundary Road and Glenlyon Creek, referred to as 'Reach 9". The work includes construction of a new dyke with a 4.38 m crest width, with side lopes and/or lock-block retaining walls.

THAT a construction contract be awarded to the lowest bidder King Hoe Excavating Ltd. for a total cost of \$1,450,888.16 including GST in the amount of \$69,089.91 for work as outlined in this report. Final payment will be based on the actual quantity of goods and services delivered and unit prices as tendered.
